



RULES AND PROCEDURES GOVERNING THE HOOSIER LOTTERY
2019/2020 HOW DO YOU PLAY GIVEAWAY

The State Lottery Commission of Indiana (“Lottery” or “Hoosier Lottery”), hereby promulgates these rules and procedures (“Official Rules”) governing the Hoosier Lottery 2019/2020 How Do You Play Giveaway (“Giveaway”).

A. PURPOSE

The Giveaway will be held to capture Hoosier Lottery player stories and award a Hoosier Lottery prize pack to five (5) winners.

B. GIVEAWAY PERIOD

1. The Giveaway period will begin on or about 12:00 AM (ET) on Tuesday, December 17, 2019 and the Giveaway entry deadline will be at 11:59 PM (ET) on Sunday, March 29, 2020.

C. GIVEAWAY & PRIZE DESCRIPTIONS

1. The Giveaway will be conducted in accordance with all applicable statutes, regulations, rules for the listed Prizes:

Wednesday, April 1, 2020	Five (5)	One (1) myLOTTERY Tech kit (value of \$22), one myLOTTERY Bluetooth speaker (value of \$9), one (1) myLOTTERY micro-fiber cloth (value of \$3.50), one (1) myLOTTERY T-shirt (value of \$10), and one (1) prize pack that includes \$30 of Hoosier Lottery Tickets. Total retail value \$74.50.

2. Hoosier Lottery tickets awarded will be at the discretion of the Lottery.

D. ELIGIBILITY

1. This Giveaway is open to legal residents of Indiana who are eighteen (18) years of age or older at the time of entry.
2. State Lottery Commission of Indiana members, officers, and employees, and any relative(s) (spouse, parents, siblings and children) and/or person(s) residing in the same household of such Hoosier Lottery member, officer, or employee are not eligible to participate in this Giveaway. This restriction applies *mutatis mutandis* to the Lottery's Integrated Service Provider, IGT Indiana, LLC, ("IGT").
3. Members, directors, officers, or employees of a major procurement vendor of the Hoosier Lottery and/or IGT, and any relative(s) (spouse, parents, siblings and children) and/or person(s) residing in the same household of such persons are not eligible to participate in this Giveaway.
4. No purchase necessary. Void where prohibited.

E. HOW TO PARTICIPATE

1. Participants must complete the required entry information about "How You Play" via the Hoosier Lottery's website located at hoosierlottery.com. Required entry information will include name, date of birth, city and email address. Email address may be used for Hoosier Lottery communications, including promotional emails.
2. Only one (1) entry per person. Any duplicate entries will be removed prior to the selection of winners.
3. An automated "Thank You" message will be displayed to notify the participant of a completed entry into the Giveaway. The "Thank You" message notification is only evidence that an entry has been received and does not indicate that the entry is valid.
4. All entries submitted in the manner as described in these Official Rules will be eligible for an entry in this Giveaway. Hand delivered or mailed in entries will not be accepted for this Giveaway and will be deemed invalid and destroyed.

F. ODDS OF WINNING

The odds of winning a prize are dependent upon the total number of entrants.

G. DRAWING, WINNER NOTIFICATION AND CLAIMING OF PRIZE

1. The winners of this Giveaway will be selected from among all eligible entries received by using a random number generator from random.org under the

supervision of a member of the Hoosier Lottery Security team. A total of ten (10) alternates will also be selected.

2. The winning entries for this Giveaway will be notified in writing via email and by phone call with email address and phone number provided with the entrant's contact information. Winner must claim prize within five (5) business days. After five (5) business days, the prize may be offered to an alternate. If all alternates are exhausted, the prize(s) shall be forfeited.
3. Upon timely presentation of winner information, the entry will be validated and eligibility will be verified as in Section D ("Eligibility").
4. Once Winner Verification and Winner Authorization are complete, Prize will be provided to Winner.
5. Prize may be claimed by mail, but the Indiana resident must have an Indiana address.
6. Prize awarded during this Giveaway is transferable, but only transferable to someone eighteen (18) years of age or older.


H. GENERAL RULES AND PROVISIONS

1. The rules and procedures set forth in these Official Rules shall govern this Giveaway. These rules may be amended at any time by the Hoosier Lottery without advance notice.
2. The Lottery's Executive Director or her designee may, at any time, announce a suspension or termination of the Giveaway, without advance notice and in the Executive Director's sole discretion, at which point no Prize shall be awarded. The Lottery, the Executive Director, IGT, nor any employee thereof, shall have any liability whatsoever for any such termination.
3. By participating in the Giveaway each person agrees to comply with and abide by Indiana law, rules, and regulations as well as the terms and conditions of the Lottery website and all final decisions, policies, or procedures of the Lottery in relation to the conduct of this Giveaway. Any dispute arising which relates to any aspect of this Giveaway shall be governed by the laws of Indiana.
4. In the event of a dispute arising out of these Official Rules, the player's remedy is limited to entry in another Giveaway with prizes of a similar value.
5. The Lottery, IGT, and their agents are not responsible for error, omission, interruption, deletion, defect, delay in operations, theft or destruction, unauthorized access to or alterations of Giveaway, failure to receive claim, winner, or other Giveaway information for any reason whatsoever.

6. The Hoosier Lottery is not responsible for issues with account accessibility or Giveaway entries due to technical problems associated to software, hardware compatibility or internet access.
7. By participating in the Promotion each person agrees that the Lottery, IGT, and their agents may use the person's first name and city name in digital marketing materials created in connection with this Promotion. Use of this information will be in accordance with the Lottery's Privacy Policy available at <https://hoosierlottery.com/privacy-policy>.
8. By entering this Giveaway, each entrant agrees to follow these Official Rules and forever releases, discharges, and waives any and all claims, liabilities and actions of any kind, howsoever caused or arising and whether by negligence, any intentional act or otherwise, that entrant may have or that may arise against the Hoosier Lottery, IGT, and each of their respective parents, subsidiaries, affiliates, and related entities, as well as each of the aforementioned parties' respective associates, directors, officers, owners, shareholders, partners, members, employees, agents, representatives, successors and assigns (collectively, the "Released Parties"), with respect to or arising directly or indirectly, out of, or in any way connected with, (i) entrant's participation in this Giveaway; or (ii) the receipt or use of the prizes (including but not limited to the substitution or changing of any prizes) awarded in this Giveaway. By entering, each entrant further agrees to defend, indemnify and hold harmless the Released Parties and their insurers against any and all damages, costs, judgments, and/or expenses (including but not limited to attorneys' fees and/or other legal fees) they may incur as a result of claims made against them in connection with either (i) entrant's participation in this Giveaway; or (ii) the receipt or use of the prizes (including but not limited to the substitution or changing of any prizes) awarded in this Giveaway. This Giveaway is in no way sponsored, endorsed, or administered by, or associated with Facebook or Instagram. Players are providing information to the Hoosier Lottery and not to Facebook or Instagram.
