WILD CHERRY CROSSWORD 5X

1. The name of scratch-off game number 2298 is "WILD CHERRY CROSSWORD 5X".

2. Tickets in scratch-off game number 2298 shall sell for five dollars (\$5) per ticket, unless otherwise adjusted by temporary price reductions or other promotional activities conducted or authorized by the Commission.

3. (a) Each ticket in scratch-off game number 2298 shall contain a total of eighteen (18) play symbols under a scratch-off material covering the game play data area.

(b) The game play data area of each ticket in scratch-off game number 2298 shall be divided into eight (8) distinct game areas as follows:

(1) An area labeled "YOUR LETTERS" that contains eighteen (18) play symbols.

(2) A game area composed of a crossword grid that contains a completed crossword puzzle (Puzzle 1).

(3) A second game area composed of a crossword grid that contains a completed crossword puzzle (Puzzle 2).

(4) A game area labeled "CONNECT BONUS WORD".


(5) Four (4) BONUS WORDS labeled "\$5 BONUS", "\$10 BONUS", "\$20 BONUS" and "\$50 BONUS".

(c) The available play symbols are as follows:


A B C D E F G H I
J K L M N O P Q R
S T U V W X Y Z



(d) The available play symbols appearing in the crossword grid play area

includes the play symbols in Subsection (c) of this SECTION 3 as well as the ""

(BLACK CHERRY) AND “” (RED CHERRY) symbols. The “”

(BLACK CHERRY) AND “” (RED CHERRY) symbols can be used to replace one or more of the play symbols to form a complete word(s) in the crossword grid areas.

(e) A chart labeled "PRIZE KEY" shall appear to the left of the Puzzle 2 and shall contain a table setting forth prize requirements and amounts.

4. The:

- (1) retailer validation code;
- (2) game/pack/ticket number; and
- (3) validation number;


that appear on each ticket in scratch-off game number 2298 are for Commission or retailer use only and cannot be used or played as a play or prize symbol to win a prize.


5. (a) To play a ticket in scratch-off game number 2298, the ticket must be validly purchased and the scratch-off material covering the game play data area labeled "YOUR LETTERS" must be fully removed. Each of the seven (7) puzzles (Puzzle 1, Puzzle 2, "CONNECT BONUS WORD", "\$5 BONUS", "\$10 BONUS", "\$20 BONUS" and "\$50 BONUS") are played separately. Multiple prizes may be won on this ticket.

(b) Prizes are dependent on the number of words formed in the crossword grids using the play symbols in the "YOUR LETTERS" play area. The play symbols in the "YOUR LETTERS" play area must match all of the letters in a word that appears in the crossword grids in order to form a complete word. Letters combined to form a complete word must appear in an unbroken horizontal or vertical sequence on the crossword grids.

(c) If three (3) or more complete words are formed in the Puzzle 1 crossword grid from the play symbols in the "YOUR LETTERS" play area, the ticket may be redeemed for the prize identified on the "PRIZE KEY".

(d) If three (3) or more complete words are formed in the Puzzle 2 crossword grid from the play symbols in the "YOUR LETTERS" play area, the ticket may be redeemed for the prize identified on the "PRIZE KEY".

(e) If one of the winning words includes the “” (BLACK CHERRY) in the place of a letter in the word, the player automatically wins three (3) times the prize identified in the "PRIZE KEY".

(f) If one of the winning words includes the “” (RED CHERRY) in the place of a letter in the word, the player automatically wins five (5) times the prize identified in the "PRIZE KEY".

(g) If a complete word is formed in the "CONNECT BONUS WORD" play area from the play symbols in the "YOUR LETTERS" play area, the ticket may be

redeemed for twenty-five dollars (\$25). The "CONNECT BONUS WORD" cannot be used as a completed word in either Puzzle 1 or Puzzle 2.

(h) If a complete word is formed in the "\$5 BONUS" play area from the play symbols in the "YOUR LETTERS" play area, the ticket may be redeemed for five dollars (\$5). The "\$5 BONUS" word cannot be used as a completed word in either Puzzle 1 or Puzzle 2.

(i) If a complete word is formed in the "\$10 BONUS" play area from the play symbols in the "YOUR LETTERS" play area, the ticket may be redeemed for ten dollars (\$10). The "\$10 BONUS" word cannot be used as a completed word in either Puzzle 1 or Puzzle 2.

(j) If a complete word is formed in the "\$20 BONUS" play area from the play symbols in the "YOUR LETTERS" play area, the ticket may be redeemed for twenty dollars (\$20). The "\$20 BONUS" word cannot be used as a completed word in either Puzzle 1 or Puzzle 2.

(k) If a complete word is formed in the "\$50 BONUS" play area from the play symbols in the "YOUR LETTERS" play area, the ticket may be redeemed for fifty dollars (\$50). The "\$50 BONUS" word cannot be used as a completed word in either Puzzle 1 or Puzzle 2.


