

Cash POP™ Game Rules

1. Name

(a) The name of this game is "Cash POP". As used in these game rules, the term "Cash POP" shall include Cash POP – Morning, Cash POP – Matinee, Cash POP – Afternoon, Cash POP – Evening, and Cash POP – Late Night unless context requires otherwise.

2. Independent draw games

- (a) Cash POP shall be conducted as five (5) separate and independent draw games designated Cash POP Morning, Cash POP Matinee, Cash POP Afternoon, Cash POP Evening, and Cash POP Late Night, respectively. Tickets in each of the five (5) Cash POP games are not associated with each other and are only valid for the selected game. The five (5) games shall have separate selection events and winning numbers. Notwithstanding the foregoing, the odds, play styles, and prizes shall be identical in all five Cash POP games.
- (b) If the player elects to make a wager for multiple draws, the player may choose up to 28 consecutive draws of the specified game(s) and a separate ticket will be produced for each selection event. If no game is specified, ticket(s) produced will be for the next consecutive selection event(s) following the first selection event for which the ticket is valid.

3. Definitions

- (a) The definitions in Indiana Code 4-30, 65 IAC, and this section apply throughout these game rules.
 - (b) "Cash POP" is the name of the base game.
- (c) "Cash POP selection event" means a drawing or other selection event conducted to determine the one (1) winning Cash POP number.
 - (d) "Wager" means the dollar amount which the player elects to play per number selected.
- (e) "Winning Cash POP number" means the one (1) number, from a field of numbers ranging from one (1) to fifteen (15), determined in a specific Cash POP selection event and announced as such pursuant to Section 6 of these game rules.

4. Ticket Price

- (a) The wager for each selected Cash POP number in one (1) selection event for Cash POP must be made in the amount of one dollar (\$1), two dollars (\$2), five dollars (\$5) or ten dollars (\$10).
- (b) Total cost for each ticket is determined by the number of Cash Pop number(s) the player chooses to play, multiplied by the wager amount, multiplied by the number of Cash POP selection events in which the player chooses to play.

5. Procedure for playing

- (a) A single play, applicable to a particular selection event for Cash POP, shall include the selection of:
 - (1) the amount wagered under Section 4 of this rule; and
 - 2) one (1) to fifteen (15) numbers ranging from one (1) to fifteen (15).
 - (b) A ticket for Cash POP will represent only one (1) play.
- (c) A valid ticket for a Cash POP selection event must originate from the State Lottery Commission of Indiana. A ticket may only be issued after the information and purchaser elections required by these game rules are entered into a terminal.
- (d) A ticket is the only valid proof of a play and the only valid receipt for claiming a prize resulting from a Cash POP selection event. A playslip shall have no pecuniary or prize value and shall not constitute evidence of purchase of a ticket or a play.
- (e) Unless otherwise indicated on the playslip, a ticket for Cash POP is effective for the next scheduled Cash POP selection event. The selection of more than one selection event will produce a separate ticket for each event selected.
- (f) Sales of tickets for Cash POP selection events shall be suspended prior to the time of the associated selection event at a time determined by the Director.
- (g) If a paper playslip is used to select a player's number(s) for a Cash POP selection event, the playslip must have been issued by the Lottery and completed by hand. The playslip will be scanned by the terminal or keyed in by hand by the retailer.
- (h) If a digital playslip is used from the Hoosier Lottery "myPlayslip" app feature to select a player's number(s) for a Cash POP selection event, the player's device must be scanned by the terminal.
 - (i) A purchased ticket for Cash POP is not cancellable.
- (j) Entry coupons may be generated by terminals for certain purchases of tickets for Cash POP.

6. Determination of winning numbers

- (a) Selection events for determination of the winning number for Cash POP shall be held five (5) times each day.
 - (b) Each selection event in a Cash POP game shall:
 - (1) Be conducted in accordance with 65 IAC 7-1-8 at a time to be determined by the Director or the Director's designee.
 - (2) Determine one (1) randomly selected winning number, ranging between one (1) and fifteen (15).

7. Determination of winners

(a) Each holder of a valid ticket for a Cash POP selection event on which one (1) number in a play applicable to that selection event matches the one (1) winning Cash POP number is entitled to the prize randomly assigned to the Cash POP number on the player's ticket.

8. Determination of prize amounts and odds of winning

- (a) The overall odds of a single number winning a cash prize are 1 in 15.
- (b) Prizes and odds for each Cash POP selection event shall be determined based on the wager amount chosen by the player (\$1, \$2, \$5, or \$10) as below:
