WILD CASH MULTIPLIER

1. The name of Fast Play game number 0128 is “WILD CASH MULTIPLIER”.

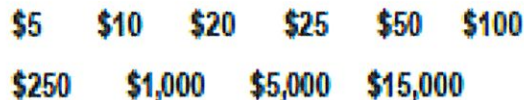
2. Tickets in Fast Play game number 0128 shall sell for five dollars (\$5) per ticket, unless otherwise adjusted by temporary price reductions or other promotional activities conducted or authorized by the Commission.

3. (a) Each ticket in Fast Play game number 0128 shall contain a total of forty (40) play symbols (twenty-seven (27) symbols denoted as GAMES (“LINE 1” through “LINE 9”), three (3) symbols denoted as “MULTIPLIER” and ten (10) symbols denoted as “WINNING SYMBOLS” and a total of nine (9) prize symbols.

(b) Each play symbol is represented as follows:

4. (a) To play a ticket in Fast Play game number 0128, the ticket must be validly purchased from a Hoosier Lottery terminal.

(b) If any of the play symbols in the area labeled “WINNING SYMBOLS” match all three (3) of the play symbols in any individual LINE labeled

“LINE 1” through “LINE 9”, the ticket may be redeemed for a prize in the amount represented by the prize symbol that is located in the “PRIZE” box to the right of and corresponding to the three (3) matching play symbols for that LINE. Each LINE is played separately.

(c) If all six (6) of the play symbols in the area labeled as “GAME 1” (“LINE 1” and “LINE 2”) match six (6) of the play symbols in the area labeled “WINNING SYMBOLS”, the ticket may be redeemed for a prize two (2) times the sum of the two (2) prize symbols located in the “PRIZE” boxes to the right of and corresponding to the six (6) matching play symbols for “GAME 1”.

(d) If all nine (9) of the play symbols in the area labeled as “GAME 2” (“LINE 3”, “LINE 4” and “LINE 5”) match nine (9) of the play symbols in the area labeled “WINNING SYMBOLS”, the ticket may be redeemed for a prize three (3) times the sum of the three (3) prize symbols located in the “PRIZE” boxes to the right of and corresponding to the nine (9) matching play symbols for “GAME 2”.

(e) If all twelve (12) of the play symbols in the area labeled as “GAME 3” (“LINE 6”, “LINE 7”, “LINE 8” and “LINE 9”) match twelve (12) of the play symbols in the area labeled “WINNING SYMBOLS”, the ticket may be redeemed for a prize five (5) times the sum of the four (4) prize symbols located in the “PRIZE” boxes to the right of and corresponding to the twelve (12) matching play symbols for “GAME 3”.

5. Fast Play game number 0128, “WILD CASH MULTIPLIER,” is not cancellable once printed.

6. (a) The odds for each prize level are as follows:

7. For a Fast Play ticket to be validated, all of the following must be met:

(1) The ticket must be printed on paper stock which was validly issued to and used by the terminal from which the ticket was printed at the time of purchase;

(2) The ticket has not been altered, torn, misprinted, found to be illegible, defaced, or damaged in such a manner that validation is impossible;

(3) The ticket is not counterfeit in whole or in part;

(4) The ticket has not been reconstituted or tampered with in any manner;

(5) The typeface and artwork of play symbols, captions, or characters used as play selections must correspond with the typeface and artwork of play symbols, captions, or characters established by the Commission in these approved Game Rules, working papers, or other specifications applicable to the play of game number 0128;

(6) Each play symbol or character must be present in its entirety and fully legible or the ticket must be capable of being validated via the ticket barcode or transaction number as printed on the ticket; and

(7) The ticket must pass any additional validation test prescribed by the Commission, which for security reasons may be confidential in nature.

8. Tickets are drawn from a constantly replenished statewide pool of winning and non-winning outcomes based on the established odds. When an outcome, winning or non-winning, is randomly selected from the pool, it is then immediately replaced so the pool size and chance to win each prize remains the same for each ticket.

9. Tickets expire 180 days from date of purchase.

10. This document expires sixty (60) days after the last claim date established for Fast Play game number 0128.
