1. The name of scratch-off game number 2329 is "SAPPHIRE MINE 20X".
2. Tickets in scratch-off game number 2329 shall sell for five dollars (\$5) per ticket, unless otherwise adjusted by temporary price reductions or other promotional activities conducted or authorized by the Commission.
3. (a) Each ticket in scratch-off game number 2329 shall contain a total of twenty-five (25) play symbols and up to twenty (20) prize symbols under a scratch-off material covering the game play data area.
(b) Each play symbol includes a caption that corresponds with and verifies the play symbol as follows:

- (c) Each prize symbol includes a caption that corresponds with and verifies the prize symbol as follows:

(d) If a question arises as to a play or prize symbol, the caption that corresponds with the play or prize symbol will be used for final clarification.



4. The:



- (1) retailer validation code;
- (2) game/pack/ticket number; and
- (3) validation number;



that appear on each ticket in scratch-off game number 2329 are for Commission or retailer use only and cannot be used or played as a play or prize symbol to win a prize.


5. (a) To play a ticket in scratch-off game number 2329, the ticket must be validly purchased and the scratch-off material covering the game play data area must be fully removed. Multiple prizes may be won on this ticket. In accordance with Sections 5(f), 5(g), 5(h) and 5(i), only the highest prize will be paid if “” (GEM) symbols are found.


(b) If any of the play symbols in the area labeled “YOUR NUMBERS” match any of the play symbols in the area labeled “WINNING NUMBERS”, the ticket may be redeemed for a prize in the amount represented by the prize symbol that is located directly below and corresponding to the matching play symbols.


(c) If a “” (5X) play symbol is revealed in the area labeled “YOUR NUMBERS”, the ticket may be redeemed for a prize five (5) times the amount represented by the prize symbol that is located directly below and corresponding to the “” (5X) play symbol.

(d) If a “” (10X) play symbol is revealed in the area labeled “YOUR NUMBERS”, the ticket may be redeemed for a prize ten (10) times the amount represented by the prize symbol that is located directly below and corresponding to the “” (10X) play symbol.


(e) If a “” (20X) play symbol is revealed in the area labeled “YOUR NUMBERS”, the ticket may be redeemed for a prize twenty (20) times the amount represented by the prize symbol that is located directly below and corresponding to the “” (20X) play symbol.

(f) If a “” (GEM) play symbol is revealed in the area labeled “YOUR NUMBERS”, the ticket may be redeemed for twenty dollars (\$20).

(g) If two (2) “” (GEM) play symbols are revealed in the area labeled “YOUR NUMBERS”, the ticket may be redeemed for fifty dollars (\$50).

(h) If three (3) “” (GEM) play symbols are revealed in the area

labeled “YOUR NUMBERS”, the ticket may be redeemed for one hundred dollars (\$100).

(i) If four (4) “” (GEM) play symbols are revealed in the area labeled “YOUR NUMBERS”, the ticket may be redeemed for two hundred dollars (\$200).
