



**Game Number 2303
WILD CHERRY CROSSWORD TRIPLER**

1. The name of scratch-off game number 2303 is "WILD CHERRY CROSSWORD TRIPLER".

2. Tickets in scratch-off game number 2303 shall sell for three dollars (\$3) per ticket, unless otherwise adjusted by temporary price reductions or other promotional activities conducted or authorized by the Commission.



3. (a) Each ticket in scratch-off game number 2303 shall contain a total of eighteen (18) play symbols under a scratch-off material covering the game play data area. The game play data area of each ticket in scratch-off game number 2303 shall be divided into two (2) distinct game areas as follows:

(1) An area labeled "YOUR LETTERS" that contains eighteen (18) play symbols.

(2) A game area composed of a crossword grid that contains a completed crossword puzzle.

(b) The available play symbols appearing in the "YOUR LETTERS" play area are as follows:

**A B C D E F G H I
J K L M N O P Q R
S T U V W X Y Z**

(c) The available play symbols appearing in the crossword grid play area includes the play symbols in Subsection (b) of this SECTION 3 and the "" (CHERRY) symbol. The "" (CHERRY) symbol can be used to replace one or more of the play symbols to form a complete word(s) in the crossword grid area.

(d) A chart labeled "PRIZE LEGEND" shall appear to the right of the crossword grid and shall contain a table setting forth prize requirements and amounts.

4. The:

- (1) retailer validation code;
- (2) game/pack/ticket number; and
- (3) validation number;

that appear on each ticket in scratch-off game number 2303 are for Commission or retailer

use only and cannot be used or played as a play or prize symbol to win a prize.

5. (a) To play a ticket in scratch-off game number 2303, the ticket must be validly purchased and the scratch-off material covering the game play data area labeled "YOUR LETTERS" must be fully removed.

(b) Prizes are dependent on the number of words formed in the crossword grid using the play symbols in the "YOUR LETTERS" game area. The play symbols in the "YOUR LETTERS" game area must match all of the letters in a word that appears in the crossword grid in order to form a complete word. Letters combined to form a complete word must appear in an unbroken horizontal or vertical sequence on the crossword grid.

(1) If three (3) complete words are formed in the crossword grid from the play symbols in the "YOUR LETTERS" game area, the ticket may be redeemed for three dollars (\$3).

(2) If four (4) complete words are formed in the crossword grid from the play symbols in the "YOUR LETTERS" game area, the ticket may be redeemed for five dollars (\$5).

(3) If five (5) complete words are formed in the crossword grid from the play symbols in the "YOUR LETTERS" game area, the ticket may be redeemed for ten dollars (\$10).


(4) If six (6) complete words are formed in the crossword grid from the play symbols in the "YOUR LETTERS" game area, the ticket may be redeemed for fifty dollars (\$50).

(5) If seven (7) complete words are formed in the crossword grid from the play symbols in the "YOUR LETTERS" game area, the ticket may be redeemed for one hundred dollars (\$100).

(6) If eight (8) complete words are formed in the crossword grid from the play symbols in the "YOUR LETTERS" game area, the ticket may be redeemed for five hundred dollars (\$500).

(7) If nine (9) complete words are formed in the crossword grid from the play symbols in the "YOUR LETTERS" game area, the ticket may be redeemed for one thousand dollars (\$1,000).

(8) If ten (10) complete words are formed in the crossword grid from the play symbols in the "YOUR LETTERS" game area, the ticket may be redeemed for fifty thousand dollars (\$50,000).

(c) If one of the formed words includes the "" (CHERRY) symbol in the place of a letter in the word, the player automatically wins three (3) times the prize identified in the "PRIZE LEGEND".
