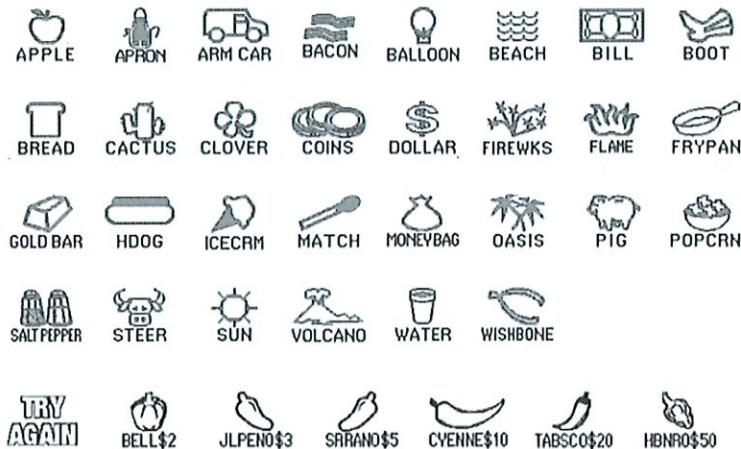




**Game Number 2415
BRING ON THE HEAT**

1. The name of scratch-off game number 2415 is “BRING ON THE HEAT”.
2. Tickets in scratch-off game number 2415 shall sell for two dollars (\$2) per ticket, unless otherwise adjusted by temporary price reductions or other promotional activities conducted or authorized by the Commission.
3. (a) Each ticket in scratch-off game number 2415 shall contain a total of twenty-five (25) play symbols and a total of six (6) prize symbols under a scratch-off material covering the game play data area.
(b) Each play symbol includes a caption that corresponds with and verifies the play symbol as follows:



- (c) Each prize symbol includes a caption that corresponds with and verifies the prize symbol as follows:



- (d) If a question arises as to a play or prize symbol, the caption that corresponds with the play or prize symbol will be used for final clarification.

4. The:
 - (1) retailer validation code;
 - (2) game/pack/ticket number; and
 - (3) validation number;that appear on each ticket in scratch-off game number 2415 are for Commission or

retailer use only and cannot be used or played as a play or prize symbol to win a prize.

5. (a) To play a ticket in scratch-off game number 2415, the ticket must be validly purchased and the scratch-off material covering the game play data area must be fully removed.

(b) Each GAME labeled "GAME 1" through "GAME 6" is played separately. Play symbols in one GAME area cannot be used or played to win a prize in another GAME area.

(c) If three (3) matching play symbols are revealed in any individual GAME labeled "GAME 1" through "GAME 6", the ticket may be redeemed for a prize in the amount represented by the prize symbol that is located to the right of and corresponding with the three (3) matching play symbols for that GAME.

(i) If prizes are won in both GAMES labeled "GAME 1" and "GAME 2", the ticket may be redeemed for a prize two (2) times the amount represented by the prize symbols located to the right of and corresponding with the three (3) matching play symbols for those GAMES ("GAME 1" and "GAME 2").

(ii) If prizes are won in both GAMES labeled "GAME 3" and "GAME 4", the ticket may be redeemed for a prize three (3) times the amount represented by the prize symbols located to the right of and corresponding with the three (3) matching play symbols for those GAMES ("GAME 3" and "GAME 4").

(iii) If prizes are won in both GAMES labeled "GAME 5" and "GAME 6", the ticket may be redeemed for a prize five (5) times the amount represented by the prize symbols located to the right of and corresponding with the three (3) matching play symbols for those GAMES ("GAME 5" and "GAME 6").



(d) If "BELL\$2" (BELL PEPPER) play symbol is revealed in area labeled "BONUS PEPPER", the ticket may be redeemed for two dollars (\$2).



(e) If "JALPEÑO\$3" (JALAPEÑO PEPPER) play symbol is revealed in area labeled "BONUS PEPPER", the ticket may be redeemed for three dollars (\$3).



(f) If "SERRANO\$5" (SERRANO PEPPER) play symbol is revealed in area labeled "BONUS PEPPER", the ticket may be redeemed for five dollars (\$5).



(g) If "CAYENNE\$10" (CAYENNE PEPPER) play symbol is revealed in area labeled "BONUS PEPPER", the ticket may be redeemed for ten dollars (\$10).



(h) If "TABASCO\$20" (TABASCO PEPPER) play symbol is revealed in area labeled "BONUS PEPPER", the ticket may be redeemed for twenty dollars (\$20).



(i) If "HABANERO\$50" (HABANERO PEPPER) play symbol is revealed in area labeled "BONUS PEPPER", the ticket may be redeemed for fifty dollars (\$50).

6. (a) The approximate number of possible prizes and the estimated odds for each prize level are as follows:

(b) The number of prizes and the estimated odds provided in subsection (a) are calculated based on total print quantity of tickets. The actual number of prizes and the chances of winning a prize will vary as prizes are claimed.

(c) If there are reorders of the game, the ratio of prizes and total value of all prizes to the print quantity will be proportionately maintained so that the overall odds and prize payout percentage will approximate the values provided in subsection (a).
