(c) Each prize symbol includes a caption that corresponds with and verifies the prize symbol as follows:

<b>\$5.00</b> FIVE	<b>\$10.00</b> TEN	<b>\$20.00</b> TWENTY
<b>\$50.00</b> FIFTY	<b>\$75.00</b> SVYFIV	<b>\$100</b> ONEHUN
<b>\$250</b> 2HUN50	<b>\$500</b> FIVHUN	<b>\$5,000</b> 5THOU
<b>\$125,000</b> 125THOU		

(d) If a question arises as to a play or prize symbol, the caption that corresponds with the play or prize symbol will be used for final clarification.

4. The:

- (1) retailer validation code;
- (2) game/pack/ticket number; and
- (3) validation number;

that appear on each ticket in scratch-off game number 2463 are for Commission or retailer use only and cannot be used or played as a play or prize symbol to win a prize.

5. (a) To play a ticket in scratch-off game number 2463, the ticket must be validly purchased and the scratch-off material covering the game play data area must be fully removed.

(b) If any of the play symbols in the area labeled "YOUR CARDS" match any of the play symbols in the area labeled "WINNING CARDS", the ticket may be redeemed for a prize in the amount represented by the prize symbol that is located directly below and corresponding to the matching play symbol.



(c) If a "WIN2X" (JOKER CARD) play symbol is revealed in the area labeled "YOUR CARDS", the ticket may be redeemed for a prize two (2) times the amount represented by the prize symbol that is located directly below and corresponding to



the "WIN2X" (JOKER CARD) play symbol.



(d) If a "WINS20" (ACE OF DIAMONDS) prize symbol is revealed in the area labeled "YOUR CARDS", the ticket may be redeemed for twenty dollars (\$20).



(e) If a "WINS50" (ACE OF CLUBS) prize symbol is revealed in the area labeled "YOUR CARDS", the ticket may be redeemed for fifty dollars (\$50).



(f) If a "WINS75" (ACE OF HEARTS) prize symbol is revealed in the area

labeled "YOUR CARDS", the ticket may be redeemed for seventy-five dollars (\$75).



(g) If a "WINSTOO" (ACE OF SPADES) prize symbol is revealed in the area labeled "YOUR CARDS", the ticket may be redeemed for one hundred dollars (\$100).

6. (a) The approximate number of possible prizes and the estimated odds for each prize level are as follows:

(b) The number of prizes and the estimated odds provided in subsection (a) are calculated based on total print quantity of tickets. The actual number of prizes and the chances of winning a prize will vary as prizes are claimed.

(c) If there are reorders of the game, the ratio of prizes and total value of all prizes to the print quantity will be proportionately maintained so that the overall odds and prize payout percentage will approximate the values provided in subsection (a).
