

# RULES AND PROCEDURES GOVERNING THE myLOTTERY NASCAR POWERBALL PLAYOFFTM VIP EXPERIENCE PROMOTION

The State Lottery Commission of Indiana ("Hoosier Lottery" or "Lottery"), hereby promulgates these rules and procedures ("Official Rules") governing the myLOTTERY NASCAR Powerball<sup>®</sup> Playoff VIP Experience Promotion ("Promotion") in accordance with 65 IAC 1-7-4. NO PURCHASE NECESSARY. Void where prohibited.

### A. PURPOSE

The Promotion will be held to support the Hoosier Lottery's member program (myLOTTERY) by providing myLOTTERY members the opportunity to enter the Promotion for a chance to win one (1) of thirty-five (35) prize packages and entry into the multi-state NASCAR Powerball Playoff<sup>TM</sup> Promotion drawing.

#### B. PROMOTION PERIOD & DRAWING DESCRIPTION

1. The Promotion period will begin on Wednesday, May 1, 2024 at 12:00 a.m. (ET) and the final entry deadline will be Monday, June 17, 2024 at 11:59 p.m. (ET) (the "Promotion Period"). Drawing will be held on or about Thursday, June 20, 2024.

#### C. PROMOTION & PRIZE DESCRIPTIONS

- 1. There will be thirty-five (35) total winners as part of this Promotion.
- 2. The Lottery will select winners (the "Drawing") in accordance with all applicable statutes, regulations, rules and procedures and will occur on or about the following date:

- a. The thirty-five (35) winners' names drawn will be sent to MUSL (Multi-State Lottery Association) for a MUSL-run drawing to be held on Tuesday, August 13, 2024 in which MUSL will select sixteen (16) semi-finalists for the NASCAR Powerball® Playoff Promotion from entries that will come from multiple lottery jurisdictions. The sixteen (16) semi-finalists, drawn by MUSL, will go head-to-head in a series of drawings that coincide with elimination rounds during the NASCAR Playoffs to determine four (4) finalists who will win a VIP trip to the NASCAR Cup Series Championship Weekend™ at Phoenix Raceway. One (1) of the four (4) finalists will win \$1 million in a drawing broadcast live from the NASCAR Cup Series Championship Race™ on November 10, 2024. The Trip Prize description and terms are attached to these Promotion rules.
- b. If a Hoosier Lottery winner is selected as a semi-finalist by MUSL, prizes are subject to additional terms and conditions contained in the NASCAR Powerball Playoff<sup>TM</sup> prize description and prize terms and conditions as may be provided by MUSL following the selection of the semi-finalists.
- 3. myLOTTERY prize pack items awarded will be at discretion of the Lottery.
- 4. The winning prize is non-transferable to any other person, including relatives or friends. Winners will be listed at HoosierLottery.com/NASCAR.

# D. ELIGIBILITY

- 1. This Promotion is open to legal residents of Indiana who are eighteen (18) years of age or older at time of entry.
- 2. Lottery members, officers, and employees, and any relative(s) (spouse, parents, siblings and children) and/or person(s) residing in the same household of such member, officer, or employee are not eligible to participate in this Promotion. This restriction applies *mutatis mutandis* to the Lottery's Integrated Service Provider, IGT Indiana, LLC ("IGT").
- 3. Members, directors, officers, or employees of a major procurement vendor of the Lottery and/or IGT, and any relative(s) (spouse, parents, siblings, and children) and/or person(s) residing in the same household of such persons are not eligible to participate in this Promotion.
- 4. Officers, directors, members, managers, employees, contractors, of MUSL, and NASCAR and each of their respective parent, subsidiary, and/or affiliated entities, and

the immediate family and/or household members of any of the foregoing are not eligible to participate in this Promotion.

#### E. HOW TO ENTER

- Entrants can enter the promotion during the Promotion Period by visiting www.HoosierLottery.com/NASCAR to sign in or create a myLOTTERY account, which is free.
- 2. Entrants must have a current myLOTTERY account in good standing to enter this Promotion.
- 3. If an entrant does not have a myLOTTERY account, the entrant can sign up for a free account by selecting "CREATE AN ACCOUNT" on the promotion's web page or at <a href="https://www.HoosierLottery.com/mylottery">www.HoosierLottery.com/mylottery</a> to register and complete the myLOTTERY account sign up.
- 4. Once the entrant confirms their account on the promotion's web page, entrants must confirm their name, email address, phone number, and date of birth. Entrant's name must match the name on their government-issued ID.
- 5. An entrant may only enter the Promotion once. Duplicate entries will be removed at the time of the Drawing.
- 6. An automated "Thank You" message will notify the entrant of a completed entry into the Promotion. The "Thank You" message is only evidence that an entry has been received and does not indicate that the entry is valid.
- 7. All entries submitted in the manner as described in these Official Rules will be eligible for an entry in this Promotion. Hand delivered or mailed in entries will not be accepted for this Promotion and will be deemed invalid and destroyed.

#### F. ODDS OF WINNING

The odds of winning a prize are dependent upon the total number of entries received.

#### G. DRAWING, WINNER NOTIFICATION AND CLAIMING OF PRIZE

- 1. Thirty-five (35) total winners will be selected in the Drawing. Winners will be selected from among all entries received by using a random number generator from random.org under the supervision of a member of the Hoosier Lottery Security team.
- 2. Twenty-five (25) alternate winners will be selected.
- 3. The selected winners for this Promotion will be notified via email provided from the participant's myLOTTERY member account.
- 4. Entrants must provide a valid government-issued ID.
- 5. Upon timely presentation of winner information, the entry will be validated, and eligibility will be verified as in Section D outlined above.
- 6. Upon notification, the winner will have five (5) business days to respond and to claim prize. If a selected winner fails to respond within the designated time, an alternate will be selected. If all alternates are exhausted, the prize(s) will be forfeited.
- 7. Finalists are subject to the full amount of any taxes due on the total value of the Trip Prize.

- 8. For winner(s) of more than \$599, the Lottery will determine if the prize winner has an outstanding debt to the state, owes delinquent taxes, or is past due on child support pursuant to IC 4-30-11-11. If a debt is discovered, the potential winner will be required to pay the balance prior to the claim deadline. If the potential winner does not pay the outstanding debt the potential winner will forfeit the prize.
- 9. If a Hoosier Lottery player wins a VIP Trip, debts owed to the state may be checked prior to the VIP Trip, as well as after the VIP Trip to determine if a debt needs to be paid before any prize(s) can be claimed. All claims are subject to Section G(8) of these Official Rules.
- 10. Federal and state withholding tax will be deposited by the Hoosier Lottery on behalf of a winner when required by the State of Indiana and IRS tax rules. Relevant IRS forms will be provided to winners when required. The Hoosier Lottery advises its customers to consult with a tax professional when preparing taxes. Additional costs, taxes, including state and federal taxes, fees and any expenses associated with the acceptance of a prize are the sole responsibility of the winner, unless otherwise indicated.

#### H. GENERAL RULES AND PROVISIONS

- 1. The rules and procedures set forth in these Official Rules shall govern this Promotion.

  These rules may be amended at any time by the Hoosier Lottery without advance notice.
- 2. The Lottery's Executive Director or her designee may, at any time, announce a suspension or termination of the Promotion, without advance notice and in the Executive Director's sole discretion, at which point no Prize shall be awarded. None of the Lottery, the Executive Director, IGT, or any employee thereof, shall be liable for such termination.
- 3. By participating in the Promotion each person agrees to comply with and abide by the laws, rules, and regulations of the State of Indiana as well as the terms and conditions of the Lottery website and all final decisions, policies, or procedures of the Lottery in relation to the conduct of this Promotion. Any dispute arising which relates to any aspect of this Promotion shall be governed by the laws of the State of Indiana.
- 4. In the event of a dispute arising out of these Official Rules, the entrant's remedy is limited to entry in another promotion with prizes of a similar value.
- 5. The Lottery and IGT are not responsible for error, omission, interruption, deletion, defect, delay in operations, theft or destruction, unauthorized access to or alterations of Promotion, failure to receive claim, winner, or other Promotion information for any reason whatsoever.
- The Lottery and IGT are not responsible for issues with account accessibility or Promotion entries due to technical problems associated to software, hardware compatibility or internet access.
- 7. Except where prohibited by law, in consideration for being permitted to participate in this Promotion and the opportunity to win the prizes offered in this Promotion, each entrant hereby agrees and consents, without further authorization, compensation or remuneration of any kind, to the use of the entrant's name, likeness, voice, photograph, performance, personal statements and/or biographical information in any and all advertising, promotions and other publicity conducted by Lottery and IGT.

- 8. By entering this Promotion, each entrant agrees to follow these Official Rules and forever releases, discharges, and waives any and all claims, liabilities and actions of any kind, howsoever caused or arising and whether by negligence, any intentional act or otherwise, that entrant may have or that may arise against the Hoosier Lottery, IGT, Facebook, Instagram, as well as each of the aforementioned parties' respective associates, directors, officers, owners, shareholders, partners, members, employees, agents, representatives, successors and assigns (collectively, the "Released Parties"), with respect to or arising directly or indirectly, out of, or in any way connected with, (i) entrant's participation in this Promotion; or (ii) the receipt or use of the prizes (including but not limited to the substitution or changing of any prizes) awarded in this Promotion. By entering, each entrant further agrees to defend, indemnify and hold harmless the Released Parties and their insurers against any and all damages, costs, judgments, or expenses (including but not limited to attorneys' fees or other legal fees) they may incur as a result of claims made against them in connection with either (i) entrant's participation in this Promotion; or (ii) the receipt or use of the prizes (including but not limited to the substitution or changing of any prizes) awarded in this Promotion. This Promotion is in no way sponsored, endorsed, or administered by, or associated with, Facebook or Instagram. Entrants understand that they are providing their information to Lottery and/or IGT and to Facebook or Instagram.
- 9. The Lottery and IGT will be collecting personal data about entrants online, in accordance with their privacy policies, as posted on https://HoosierLottery.com/privacy-policy and https://www.igt.com/en/privacynotice. By participating in the Promotion, entrants consent to the Lottery's and IGT's collection and use of their personal information and acknowledge that they have read and accepted the Lottery's and IGT's privacy policies.
- 10. NASCAR, LLC is not a sponsor of this Promotion.

## NASCAR POWERBALL PLAYOFF™ PROMOTION (2024)

#### TRIP PRIZE DESCRIPTION

The Trip Prize consists of a four-day, three-night VIP trip for the entry selected from a pool of Participating Lotteries' entrants (each a Finalist or collectively "Finalists") and one (1) guest to Phoenix, AZ ("PHX"), from approximately Friday, November 8, 2023 to Monday, November 11, 2024, to participate in a drawing for a prize in the amount of One Million Dollars (\$1,000,000) ("\$1 Million Prize") to be conducted Sunday, November 10, 2024, during the live television broadcast of the NASCAR Cup Series Championship™ Race on NBC ("Program") from Phoenix Raceway in Avondale, AZ. The Trip Prize approximate value is \$20,000 and shall include the following elements:

- Round-trip, coach-class airline transportation for two (2) people from the major airport nearest Finalist's city to PHX (if within 250 miles of PHX, rail or ground transportation to be substituted);
- Three (3) nights hotel accommodations (selected by Prize Provider in its sole discretion) in PHX (double occupancy, room and tax only);
- Two (2) Ally Curve Hospitality Club passes (includes food, beverages and FanShield Infield Experience access) at Phoenix Raceway for admission to:
  - NASCAR Xfinity Series Championship™ Race at 4:00pm on Saturday, November 9, 2024
  - NASCAR Cup Series Championship Race™ at 1:00pm on Sunday, November 10, 2024
- Two (2) passes for VIP Experiences at Phoenix Raceway during NASCAR Championship Weekend™ for Saturday, November 9
  and Sunday, November 10, 2024 including:
  - NASCAR Cup Series™ VIP access
  - NASCAR team hauler tour
  - MRN Radio booth tour
  - Pace car rides
  - Pre-Race attendance
  - Victory Lane access
- Two (2) Official NASCAR Championship Weekend™ Event Programs;
- Two (2) Racing Electronics Scanner Rentals for use while at Phoenix Raceway;
- Two (2) Souvenir Gift Bags, each with a retail value of at least two hundred fifty dollars (\$250);
- All meals while in PHX, including a Welcome Dinner on Friday, November 8, 2024; and
- Ground transportation to and from airports, hotel, and activities in PHX.

Finalists are not required to travel to PHX to participate in the drawing for, and remain eligible to win, the \$1 Million Prize. Finalists may appoint a proxy to take the trip instead, subject to the Trip Prize Terms and Conditions, and will still remain eligible to win the \$1 Million Prize.

- Finalist (or their proxy) may also have the opportunity to participate in the recording and production of the Program and/or appear in the broadcast of the Program, provided that Finalist completes and signs all required releases and forms and consents to a background check. If Finalist appoints a proxy, the proxy must complete and sign all required releases and clear the background check in order to take the trip. In the event that Finalist's designated proxy does not clear the background check, Prize Provider reserves the right, in its sole discretion, either to (i) allow Finalist to appoint another proxy to take the trip (subject to background clearance and Prize Provider deadlines); or (ii) allow proxy to travel and to appoint a second proxy (selected by Prize Provider) to participate in the Program.
- For the avoidance of doubt, Finalist's eligibility to participate in the trip and/or the drawing for the \$1 Million Prize is not affected by Winner's failure to complete and sign all required release and forms and/or to consent to a background check and/or by any information obtained pursuant to a background check, but those failures may affect the nature of his/her appearance and/or degree of participation in the Program. While Finalist's eligibility to participate in the drawing for the \$1 Million Prize is an element of the Trip Prize, the opportunity to participate in the recording and production of the Program and/or appear in the broadcast of the Program is expressly NOT an element of the Trip Prize and is determined by Prize Provider in its sole discretion. Prize Provider reserves the right to appoint a proxy to appear and participate in the Program for Finalist for any reason as it may determine in its sole discretion. The appointment of any proxy shall not affect Finalist's eligibility for the \$1 Million Prize.
