



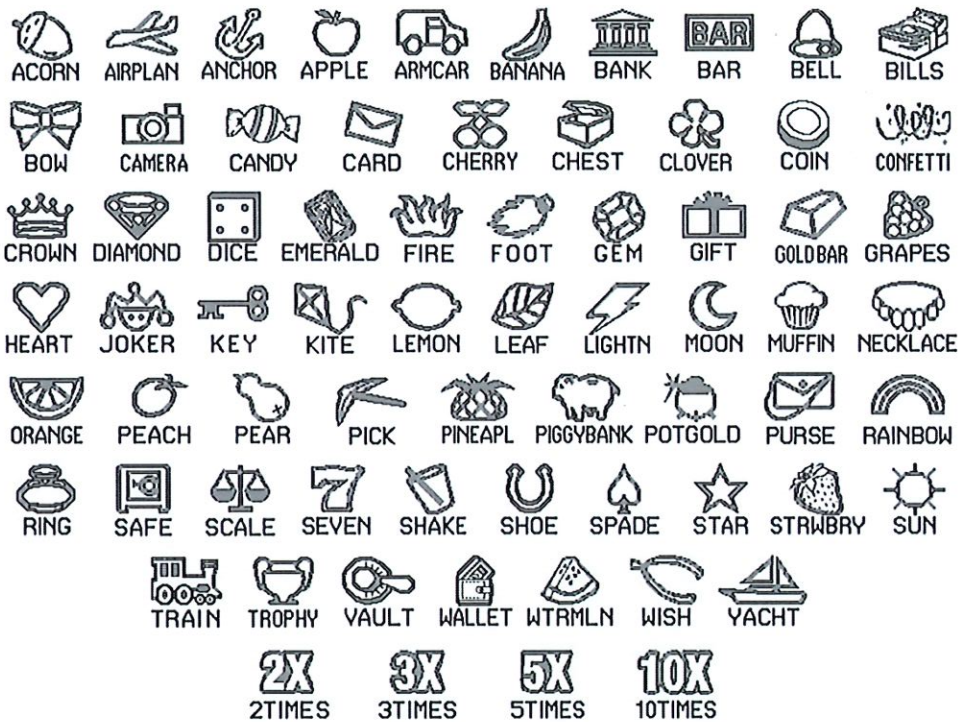
Game Number 2571  
10X THE MONEY

1. The name of scratch-off game number 2571 is "10X THE MONEY".

2. Tickets in scratch-off game number 2571 shall sell for ten dollars (\$10) per ticket, unless otherwise adjusted by temporary price reductions or other promotional activities conducted or authorized by the Commission.

3. (a) Each ticket in scratch-off game number 2571 shall contain a total of forty-eight (48) play symbols and twenty-four (24) prize symbols under a scratch-off material covering the game play data area.

(b) Each play symbol includes a caption that corresponds with and verifies the play symbol as follows:



(c) Each prize symbol includes a caption that corresponds with and verifies the prize symbol as follows:



(d) If a question arises as to a play or prize symbol, the caption that corresponds with the play or prize symbol will be used for final clarification.

4. The:

- (1) retailer validation code;
- (2) game/pack/ticket number; and
- (3) validation number;

that appear on each ticket in scratch-off game number 2571 are for Commission or retailer use only and cannot be used or played as a play or prize symbol to win a prize.

5. (a) To play a ticket in scratch-off game number 2571, the ticket must be validly purchased and the scratch-off material covering the game play data area must be fully removed.

(b) If two (2) matching play symbols are revealed in any individual GAME labeled "GAME 1" through "GAME 24", the ticket may be redeemed for a prize in the amount represented by prize symbol that is located directly below and corresponding to the two (2) matching play symbols for that GAME.

**2X**

(c) If a "2TIMES" (2X) play symbol is revealed in any individual GAME labeled "GAME 1" through "GAME 24", the ticket may be redeemed for a prize two (2) times the amount represented by prize symbol that is located directly below

**2X**

and corresponding to the "2TIMES" (2X) play symbol for that GAME.

**3X**

(d) If a "3TIMES" (3X) play symbol is revealed in any individual GAME labeled "GAME 1" through "GAME 24", the ticket may be redeemed for a prize three (3) times the amount represented by prize symbol that is located directly

**3X**

below and corresponding to the "3TIMES" (3X) play symbol for that GAME.

**5X**

(e) If a "5TIMES" (5X) play symbol is revealed in any individual GAME labeled "GAME 1" through "GAME 24", the ticket may be redeemed for a prize five (5) times the amount represented by prize symbol that is located directly below

**5X**

and corresponding to the "5TIMES" (5X) play symbol for that GAME.

**10X**

(e) If a "10TIMES" (10X) play symbol is revealed in any individual GAME labeled "GAME 1" through "GAME 24", the ticket may be redeemed for a prize ten (10) times the amount represented by prize symbol that is located directly below and

**10X**

corresponding to the "10TIMES" (10X) play symbol for that GAME.

6. (a) The approximate number of possible prizes and the estimated odds for each prize level are as follows:

(b) The number of prizes and the estimated odds provided in subsection (a) are calculated based on total print quantity of tickets. The actual number of prizes and the chances of winning a prize will vary as prizes are claimed.

(c) If there are reorders of the game, the ratio of prizes and total value of all prizes to the print quantity will be proportionately maintained so that the overall odds and prize payout percentage will approximate the values provided in subsection (a).
