



**Hoosier Lottery**  
**1/30/21 Evening Daily 3 Lost Ticket Claim Form and Affidavit**  
**Deadline for Claim is July 29, 2021**

The Hoosier Lottery (Lottery) is committed to our players and values your purchase of our games as we raise revenue for good causes throughout the State. A technical difficulty occurred during the Daily 3 drawing on Saturday evening, January 30. The announced numbers were “9-0-2” with Superball 1. Due to the technical difficulty a secondary drawing was conducted resulting in the numbers “5-7-6” with Superball 1. The Hoosier Lottery will honor both sets of numbers for prize payment.

Players who believe they may have purchased a winning ticket based on the secondary numbers drawn but discarded the ticket after viewing the numbers initially announced, or who redeemed a winning ticket and believe they may have been eligible for a higher prize level, may submit this claim form/affidavit for review by the Hoosier Lottery. Claims must be received by the Hoosier Lottery by July 29, 2021.

I understand and agree that because the ticket was not presented for validation, or was presented for validation but not paid correctly, payment of the prize will be made only if the Lottery determines, after a complete investigation of the facts, that substantial evidence supports my claim. I further understand and agree that any payment by the Lottery shall be for the amount of the prize only and shall not include interest.
  
6. I agree to and shall return or repay to the Lottery any prize which the Lottery subsequently determines was improperly paid to me. Lottery shall provide written notice to me of any such determination and I shall return or repay the prize within thirty (30) days of receipt of such notice or as otherwise agreed by the parties in writing. In the event I fail to return or repay said prize within the thirty (30) day period, I agree to indemnify, repay or reimburse the Lottery for any and all of its

costs and expenses, including attorneys' fees and court costs, incurred in recovering the prize and shall pay the Lottery interest on the value of the prize at the rate of twelve percent (12%) per annum from the date of the improper payment.

7. I agree to and shall protect, defend and hold harmless the Lottery from and against any and every suit, action, judgment, award or claim of any kind to recover the prize based upon allegations of improper or wrongful payment. In addition, I agree to and shall indemnify, repay or reimburse the Lottery for any and all costs and expenses, including attorneys' fees, incurred as a result of such suit, action, judgment, award or claim.
8. I affirm under the penalties of perjury that the information provided in this 1/30/21 Evening Daily 3 Lost Ticket Claim Form and Affidavit is true and correct to the best of my knowledge, information and belief and is intended as an inducement to the Lottery to deliver or pay the prize to me. Further, I acknowledge and understand that the Lottery is relying on said information.
