



**Game Number 2389
FROSTY BINGO DOUBLER**

1. The name of the scratch-off game number 2389 is "FROSTY BINGO DOUBLER".
2. Tickets in scratch-off game number 2389 shall sell for three dollars (\$3) per ticket, unless otherwise adjusted by temporary price reductions or other promotional activities conducted or authorized by the Commission.
3. Scratch-off game number 2389 includes six (6) separate and independent game areas labeled "CARD 1", "CARD 2", "CARD 3", "CARD 4", "CARD 5" and "CARD 6". Each game area is played separately.
4. (a) Each ticket in scratch-off game number 2389 shall contain a total of one hundred eight-five (185) play symbols.

- (b) The game play data area of each ticket in scratch-off game number 2389 shall be divided into eight (8) distinct game areas as follows:

- (1) An area labeled "CALLER'S CARD" that contains thirty (30) play symbols;
- (2) An area labeled "BONUS NUMBERS" that contains five (5) play symbols; and
- (3) Six (6) separate game areas labeled as "CARD 1", "CARD 2", "CARD 3", "CARD 4", "CARD 5" and "CARD 6" that contain twenty-five (25) play symbols in each game play area.

5. The:

- (1) retailer validation code;
- (2) game/pack/ticket number; and
- (3) validation number;

that appear on each ticket in scratch-off game number 2389 are for Commission or retailer use only and cannot be used or played as a play or prize symbol to win a prize.

6. (a) To play a ticket in scratch-off game number 2389, the ticket must be validly purchased and the scratch-off material covering the game play data areas labeled "CALLER'S CARD" and "BONUS NUMBERS" must be fully removed.

(b) A prize can be won if the play symbols revealed in the "CALLER'S CARD" and/or the "BONUS NUMBERS" play areas match the play symbols in any of the "CARD 1" through "CARD 6" play areas and the matching play symbols, when combined with any "FREE" and "❄" (SNOWFLAKE) play symbols in any of the "CARD 1" through "CARD 6" play areas, form any of the following patterns:

- (1) Five (5) matching play symbols to complete a vertical, horizontal, or diagonal line.

The "FREE" and the "❄" (SNOWFLAKE) play symbols may be used to complete the line pattern, if found in a winning line.

- (2) One (1) matching play symbol appears in each corner to complete a four (4) corner pattern. The "❄" (SNOWFLAKE) play symbol may be used to complete the four (4) corner pattern, if located in one of the four (4) corners.

- (3) Nine (9) matching play symbols arranged diagonally from corner to corner in the form of an "X" pattern. The "FREE" and the "❄" (SNOWFLAKE) play symbols may be used to complete the "X" pattern, if found in the "X" pattern.

(c) If the matching or "FREE" play symbols follow the pattern described in (b) (1) of this section, the prize won will be:

- (1) Three dollars (\$3) if appearing in the game area labeled "CARD 1".
- (2) Five dollars (\$5) if appearing in the game area labeled "CARD 2".
- (3) Ten dollars (\$10) if appearing in the game area labeled "CARD 3".
- (4) Twenty dollars (\$20) if appearing in the game area labeled "CARD 4".
- (5) Fifty dollars (\$50) if appearing in the game area labeled "CARD 5".
- (6) One hundred dollars (\$100) if appearing in the game area labeled "CARD 6".
- (7) If any of the winning patterns as defined in (c) (1) through (c) (6) of this Section

includes a "❄" (SNOWFLAKE) play symbol, the prize won may be doubled.

(d) If the matching play symbols follow the pattern described in (b) (2) of this section, the prize won will be:

- (1) Five dollars (\$5) if appearing in the game area labeled "CARD 1".
- (2) Ten dollars (\$10) if appearing in the game area labeled "CARD 2".

- (3) Twenty dollars (\$20) if appearing in the game area labeled "CARD 3".
 (4) Fifty dollars (\$50) if appearing in the game area labeled "CARD 4".
 (5) One hundred dollars (\$100) if appearing in the game area labeled "CARD 5".
 (6) Five hundred dollars (\$500) if appearing in the game area labeled "CARD 6".
 (7) If any of the winning patterns as defined in (d) (1) through (d) (6) of this Section includes a "❄" (SNOWFLAKE) play symbol, the prize won may be doubled.
- (e) If the matching or "FREE" play symbols follow the pattern described in (b) (3) of this section, the prize won will be:
- (1) Ten dollars (\$10) if appearing in the game area labeled "CARD 1".
 (2) Fifteen dollars (\$15) if appearing in the game area labeled "CARD 2".
 (3) Thirty dollars (\$30) if appearing in the game area labeled "CARD 3".
 (4) One hundred dollars (\$100) if appearing in the game area labeled "CARD 4".
 (5) Two hundred and fifty dollars (\$250) if appearing in the game area labeled "CARD 5".
 (6) Forty-thousand dollars (\$40,000) if appearing in the game area labeled "CARD 6".
 (7) If any of the winning patterns as defined in (e) (1) through (e) (5) of this Section includes a "❄" (SNOWFLAKE) play symbol, the prize won may be doubled.

7. (a) The approximate number of possible prizes and the estimated odds for each prize level are as follows:

(b) The number of prizes and the estimated odds provided in subsection (a) are calculated based on total print quantity of tickets. The actual number of prizes and the chances of winning a prize will vary as prizes are claimed.

(c) If there are reorders of the game, the ratio of prizes and total value of all prizes to the print quantity will be proportionately maintained so that the overall odds and prize payout percentage will approximate the values provided in subsection (a).
