



RULES AND PROCEDURES GOVERNING THE HOOSIER LOTTERY'S INDY JAZZ FEST TICKET GIVEAWAY

The State Lottery Commission of Indiana ("Hoosier Lottery" or "Lottery"), hereby promulgates these rules and procedures ("Official Rules") governing the Hoosier Lottery's myLOTTERY 2026 Indy Jazz Fest Ticket Giveaway ("Promotion") in accordance with 65 IAC 1-7-4. Void where prohibited.

A. PURPOSE

The Promotion will provide participants the opportunity to enter for a chance to win two (2) tickets to Indy Jazz Fest Grand Finale on September 26, 2026. Description of the prize is found below.

B. PROMOTION PERIOD & DRAWING DESCRIPTION

1. The Promotion period will begin on or about Wednesday, September 2, 2026 at 12:00 a.m. Eastern Time and the entry deadline will be Thursday, September 3, 2026 at 11:59 p.m. Eastern Time. The drawing will be held on or about Friday, September 4, 2026.

C. PROMOTION & PRIZE DESCRIPTIONS

1. The Promotion will be conducted in accordance with all applicable statutes, regulations, rules and procedures and will occur on or about the following day for the listed prizes:

2. Any remaining and unused prizes from this promotion will be reused at the discretion of the Lottery.
3. Retail value reflects ticket cost without fees.

D. ELIGIBILITY

1. This Promotion is open to legal residents of Indiana who are eighteen (18) years of age or older at time of entry.

2. Lottery members, officers, and employees, and any relative(s) (spouse, parents, siblings and children) and/or person(s) residing in the same household of such member, officer, or employee are not eligible to participate in this Promotion. This restriction applies *mutatis mutandis* to the Lottery's Integrated Service Provider, Brightstar Lottery Indiana LLC, ("Brightstar").
3. Members, directors, officers, or employees of a major procurement vendor of the Lottery and/or Brightstar, and any relative(s) (spouse, parents, siblings, and children) and/or person(s) residing in the same household of such persons are not eligible to participate in this Promotion.
4. No purchase necessary. Void where prohibited.

E. HOW TO ENTER

1. To enter, a participant must visit www.HoosierLottery.com/myLOTTERY/IndyJazzFest, click "ENTER NOW" and confirm myLOTTERY account details or sign up for myLOTTERY which is free.
2. If an entrant does not have a myLOTTERY account, the entrant can sign up for a free account by selecting "CREATE AN ACCOUNT" on the promotion's web page or at www.HoosierLottery.com/mylottery to register and complete the myLOTTERY account sign up.
3. An entrant may only enter once. Duplicate entries will be removed at the time of the Drawing.
4. For a selected winner to successfully claim prize, the entrant's provided name must match the name on his/her government-issued ID.
5. An automated "Thank You" message will notify the entrant of a completed entry into the Promotion. The "Thank You" message is only evidence that an entry has been received and does not indicate that the entry is valid.
6. All entries submitted in the manner as described in these Official Rules will be eligible for an entry in this Promotion. Hand delivered or mailed in entries will not be accepted for this Promotion and will be deemed invalid and destroyed.

F. ODDS OF WINNING

1. The odds of winning a prize are dependent upon the total number of entries received in the applicable entry period.

G. DRAWING, WINNER NOTIFICATION AND CLAIMING OF PRIZE

1. The eight (8) prize winners will be selected from all eligible entries by using a random number generator from random.org under the supervision of a member of the Hoosier Lottery Security team.
2. A total of ten (10) alternates will be selected in sequential order. These alternate winners will also be selected using the random number generator from random.org under the supervision of a member of the Lottery Security team, after all potential winners for each Drawing have been selected. Alternates will be matched to prizes in ascending order as winners are disqualified or decline the prize.

3. The selected winners for this Promotion will be notified in writing via email and/or phone call.
4. Upon notification, a winner will have three (3) business days to respond and to claim prize. If a selected Prize winner fails to respond within the designated time, an alternate will be contacted. The alternate will have three (3) business days to respond and to claim prize. If all alternates are exhausted, then the prize will be forfeited.
5. Prize winners must provide a valid government ID either in person at any Hoosier Lottery Prize Payment Center (Indianapolis, Evansville, Mishawaka) or via email.
6. Prize may be claimed by mail, but the winner must have an Indiana address.
7. Upon timely presentation of winner information, the entry will be validated, and eligibility will be verified as in Section D outlined above.
8. Tickets will be provided via email.

H. GENERAL RULES AND PROVISIONS

1. The rules and procedures set forth in these Official Rules shall govern this Promotion. These rules may be amended at any time by the Hoosier Lottery without advance notice.
2. The Lottery's Executive Director or her designee may, at any time, announce a suspension or termination of the Promotion, without advance notice and in the Executive Director's sole discretion, at which point no Prize shall be awarded. None of the Released Parties or any employee of any of the Released Parties, shall be liable for such termination.
3. By participating in the Promotion each person agrees to comply with and abide by the laws, rules, and regulations of the State of Indiana as well as the terms and conditions of the Lottery website and all final decisions, policies, or procedures of the Lottery in relation to the conduct of this Promotion. Any dispute arising which relates to any aspect of this Promotion shall be governed by the laws of the State of Indiana.
4. In the event of a dispute arising out of these Official Rules, the entrant's remedy is limited to entry in another promotion with prizes of a similar value.
5. The Released Parties are not responsible for error, omission, interruption, deletion, defect, delay in operations, theft or destruction, unauthorized access to or alterations of Promotion, failure to receive claim, winner, or other Promotion information for any reason whatsoever.
6. The Released Parties are not responsible for issues with accessibility or Promotion entries due to technical problems associated to software, hardware compatibility or internet access.
7. Except where prohibited by law, in consideration for being permitted to participate in this Promotion and the opportunity to win the prizes offered in this Promotion, each entrant hereby agrees and consents, without further authorization, compensation or remuneration of any kind, to the use of the entrant's name, likeness, voice, photograph, performance, personal statements and/or biographical information in any and all advertising, promotions and other publicity conducted by Lottery, Brightstar, and each of their respective parents, subsidiaries, affiliates, agents, licensees.
8. Additional costs, fees and any expenses associated with the acceptance of a prize are the sole responsibility of the winner, unless otherwise indicated.

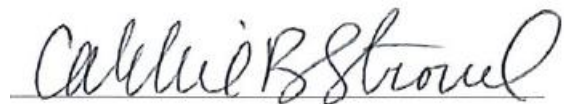

By entering, each entrant further agrees to defend, indemnify and hold harmless the Released Parties and their insurers against any and all damages, costs, judgments, or expenses (including but not limited to attorneys' fees or other legal fees) they may incur as a result of claims made against them in connection with either (i) entrant's participation in this Promotion; or (ii) the receipt or use of the prizes (including but not limited to the substitution or changing of any prizes) awarded in this Promotion.
