



RULES AND PROCEDURES GOVERNING THE HOOSIER LOTTERY
2022 INDIANA STATE FAIR FREE STAGE SEAT UPGRADE PROMOTION

The State Lottery Commission of Indiana (“Lottery” or “Hoosier Lottery”), hereby promulgates these rules and procedures (“Official Rules”) governing the 2022 Hoosier Lottery Free Stage Seat Upgrade Promotion (“Promotion”) at the Indiana State Fair.

A. PURPOSE

The Promotion will be held to promote Lottery’s sponsorship of and presence at the Indiana State Fair Free Stage.

B. PROMOTION PERIOD

1. The Promotion period will begin on or about 6:00 PM (ET) on Thursday, August 11, 2022, and will end on or about 7:00 PM (ET) on Saturday, August 20, 2022.

C. PROMOTION & PRIZE DESCRIPTIONS

1. The Promotion will be conducted in accordance with all applicable statutes, regulations, and rules for the listed Prizes:

2. The Seat Upgrade prize package includes up to six (6) front row seats at the Hoosier Lottery Free Stage. The prize may engage one or multiple groups of winners to reach up to six (6) Seat Upgrades for each selection date.

D. ELIGIBILITY

1. This Promotion is open to persons who are eighteen (18) years of age or older at the time of selection and are in attendance at the Free Stage during the time of selection.
2. State Lottery Commission of Indiana and Indiana State Fair members, officers, and employees, and any relative(s) (spouse, parents, siblings and children) and/or person(s) residing in the same household of such Hoosier Lottery or State Fair member, officer, or employee are not eligible to participate in this Promotion. This restriction applies *mutatis mutandis* to the Lottery's Integrated Service Provider, IGT Indiana, LLC, ("IGT").
3. Members, directors, officers, or employees of a major procurement vendor of the Hoosier Lottery and/or IGT, and any relative(s) (spouse, parents, siblings and children) and/or person(s) residing in the same household of such persons are not eligible to participate in this Promotion.
4. No purchase necessary. Void where prohibited.

E. ODDS OF WINNING

The odds of winning a prize are dependent upon the total number of individuals attending a Hoosier Lottery Free Stage concert on one of the nights for which the Lottery has upgraded tickets.

F. DRAWING, WINNER NOTIFICATION AND CLAIMING OF PRIZE

1. The winners will be selected randomly by Draw Station Hosts each night before or after their speaking appearance on the Hoosier Lottery Free Stage.
2. A Winner Claim Form will not be completed.
3. The Promotion winners may be required to participate in publicity and marketing efforts.
 - a. Examples include an interview with Hoosier Lottery individuals, television, radio and/or newspaper reporters and/or photographers/videographers.

- b. Effort will be made to attain each winner name and hometown, and to take a photo.
- c. This information may be used in future media, the Hoosier Lottery's website, in store Point of Purchase materials or other marketing efforts without consent or notice.

G. GENERAL RULES AND PROVISIONS

1. The rules and procedures set forth in these Official Rules shall govern this Promotion. These rules may be amended at any time by the Hoosier Lottery without advance notice.
2. The Lottery's Executive Director or her designee may, at any time, announce a suspension or termination of the Promotion, without advance notice and in the Executive Director's sole discretion, at which point no Prize shall be awarded. The Lottery, the Executive Director, IGT, State Fair, nor any employee thereof, shall have any liability whatsoever for any such termination.
3. By participating in the Promotion each person agrees to comply with and abide by Indiana law, rules, and regulations as well as the terms and conditions of the Lottery website and all final decisions, policies, or procedures of the Lottery in relation to the conduct of this Promotion. Any dispute arising which relates to any aspect of this Promotion shall be governed by the laws of Indiana.
4. In the event of a dispute arising out of these Official Rules, the player's remedy is limited to entry in another promotion with prizes of a similar value.
5. The Lottery, IGT, State Fair and their agents are not responsible for error, omission, interruption, deletion, defect, delay in operations, theft or destruction, unauthorized access to or alterations of Promotion, failure to receive claim, winner, or other Promotion information for any reason whatsoever.
6. The Hoosier Lottery and State Fair is not responsible for issues with account accessibility or Promotion entries due to technical problems associated to software, hardware compatibility or internet access.
7. By entering this Promotion, each entrant agrees to follow these Official Rules and forever releases, discharges, and waives any and all claims, liabilities and actions of any kind, howsoever caused or arising and whether by negligence, any intentional act or otherwise, that entrant may have or that may arise against the Hoosier Lottery, IGT, State Fair and each of their respective parents, subsidiaries, affiliates, and related entities, as well as each of the aforementioned parties' respective associates, directors, officers, owners, shareholders, partners, members, employees, agents, representatives,

successors and assigns (collectively, the "Released Parties"), with respect to or arising directly or indirectly, out of, or in any way connected with, (i) entrant's participation in this Promotion; or (ii) the receipt or use of the prizes (including but not limited to the substitution or changing of any prizes) awarded in this Promotion. By entering, each entrant further agrees to defend, indemnify and hold harmless the Released Parties and their insurers against any and all damages, costs, judgments, and/or expenses (including but not limited to attorneys' fees and/or other legal fees) they may incur as a result of claims made against them in connection with either (i) entrant's participation in this Promotion; or (ii) the receipt or use of the prizes (including but not limited to the substitution or changing of any prizes) awarded in this Promotion.
