

# RULES AND PROCEDURES GOVERNING THE myLOTTERY TEAM USA SUMMER SCRAMBLE PROMOTION

The State Lottery Commission of Indiana ("Lottery" or "Hoosier Lottery"), hereby promulgates these rules and procedures ("Official Rules") governing the myLOTTERY Team USA Summer Scramble Promotion ("Promotion").

## A. PURPOSE

The Promotion will be held to generate awareness of the Hoosier Lottery Team USA Fast Play and Scratch-off games and increase myLOTTERY membership and engagement.

## **B. PROMOTION PERIOD**

1. The Promotion period will begin at 12:00 AM (ET) on Tuesday, June 4, 2024, and the Promotion entry deadline will be at 11:59 PM (ET) on Monday, September 16, 2024.

## C. PROMOTION & PRIZE DESCRIPTIONS

1. The Promotion will be conducted in accordance with all applicable statutes, regulations, and rules for the listed Prizes:

- 2. Hoosier Lottery tickets awarded will be at the discretion of the Lottery.
- 3. myLOTTERY premium items will be at the discretion of the Lottery.

#### D. ELIGIBILITY

- 1. This Promotion is open to legal residents of Indiana who are eighteen (18) years of age or older at the time of entry.
- 2. State Lottery Commission of Indiana members, officers, and employees, and any relative(s) (spouse, parents, siblings and children) and/or person(s)

- residing in the same household of such Hoosier Lottery member, officer, or employee are not eligible to participate in this Promotion. This restriction applies *mutatis mutandis* to the Lottery's Integrated Service Provider, IGT Indiana, LLC, ("IGT").
- 3. Members, directors, officers, or employees of a major procurement vendor of the Hoosier Lottery and/or IGT, and any relative(s) (spouse, parents, siblings and children) and/or person(s) residing in the same household of such persons are not eligible to participate in this Promotion.
- 4. No purchase necessary. Void where prohibited.

#### E. HOW TO PARTICIPATE

- 1. Visit hoosierlottery.com/TeamUSA and create an account or log into your myLOTTERY account.
  - a. Upon initiation of the game, players will automatically be entered into the Promotion.
    - i. Players will be eligible to receive one (1) entry per week. A week is defined as Tuesday at 12:00 a.m. to Monday at 11:59 p.m. during the promotion period as described in Section B.1.
    - ii. Successful completion of Team USA Summer Scramble does not affect players' number of entries or likelihood of winning a prize in the Promotion.
    - iii. Upon exiting or finishing the game, a message will be displayed to notify the player of a completed entry into the Promotion. The message is only evidence that an entry has been received and does not indicate that the entry is valid.

# F. ODDS OF WINNING

The odds of winning a prize are dependent upon the total number of entrants.

# G. DRAWING, WINNER NOTIFICATION AND CLAIMING OF PRIZE

- 1. The winners as well as alternates of this Promotion will be selected from all eligible entries received by using a random number generator from random.org under the supervision of a member of the Lottery Security team.
- 2. Five (5) winners and five (5) alternates will be drawn on the draw date designated in Section C.1.
- 3. Entries selected as winners for this Promotion will be notified in writing via email with email address provided with the entrant's contact information.

- Winner must claim prize within ten (10) business days. After ten (10) business days, the prize may be offered to an alternate. If all alternates are exhausted, the prize(s) shall be forfeited.
- 4. Upon timely presentation of winner's government-issued ID, the entry will be validated, and eligibility will be verified as in Section D ("Eligibility").
  - a. Entry name must match name on government-issued ID.
- 5. Once verification and authorization of the winner are complete, Prize will be provided to the winner.
- 6. Prize may be claimed by mail, but the winner must have an Indiana address.

#### H. GENERAL RULES AND PROVISIONS

- 1. The rules and procedures set forth in these Official Rules shall govern this Promotion. These rules may be amended at any time by the Lottery without advance notice.
- 2. The Lottery's Executive Director or her designee may, at any time, announce a suspension or termination of the Promotion, without advance notice and in the Executive Director's sole discretion, at which point no Prize shall be awarded. None of the Lottery, the Executive Director, IGT, or any employee thereof, shall have any liability whatsoever for any such termination.
- 3. By participating in the Promotion each person agrees to comply with and abide by Indiana law, rules, and regulations as well as the terms and conditions of the Lottery website and all final decisions, policies, or procedures of the Lottery in relation to the conduct of this Promotion. Any dispute arising which relates to any aspect of this Promotion shall be governed by the laws of Indiana.
- 4. In the event of a dispute arising out of these Official Rules, the player's remedy is limited to entry in another promotion with prizes of a similar value.
- 5. The Lottery, IGT, and their agents are not responsible for error, omission, interruption, deletion, defect, delay in operations, theft or destruction, unauthorized access to or alterations of the Promotion, failure to receive claim, winner, or other Promotion information for any reason whatsoever.
- 6. The Lottery is not responsible for issues with account accessibility or Promotion entries due to technical problems associated to software, hardware compatibility or internet access.
- 7. By entering this Promotion, each entrant agrees to follow these Official Rules and forever releases, discharges, and waives any and all claims, liabilities and actions of any kind, howsoever caused or arising and whether by negligence, any intentional act or otherwise, that entrant may have or that may arise against the Lottery, IGT, and each of their respective parents, subsidiaries, affiliates, and related entities, as well as each of the aforementioned parties'

respective associates, directors, officers, owners, shareholders, partners, members, employees, agents, representatives, successors and assigns (collectively, the "Released Parties"), with respect to or arising directly or indirectly, out of, or in any way connected with, (i) entrant's participation in this Promotion; or (ii) the receipt or use of the prizes (including but not limited to the substitution or changing of any prizes) awarded in this Promotion. By entering, each entrant further agrees to defend, indemnify and hold harmless the Released Parties and their insurers against any and all damages, costs, judgments, and/or expenses (including but not limited to attorneys' fees and/or other legal fees) they may incur as a result of claims made against them in connection with either (i) entrant's participation in this Promotion; or (ii) the receipt or use of the prizes (including but not limited to the substitution or changing of any prizes) awarded in this Promotion.
