- 1. The name of scratch-off game number 2334 is "\$150,000 FORTUNE".
- 2. Tickets in scratch-off game number 2334 shall sell for five dollars (\$5) per ticket, unless otherwise adjusted by temporary price reductions or other promotional activities conducted or authorized by the Commission.
- 3. (a) Each ticket in scratch-off game number 2334 shall contain a total of twenty-five (25) play symbols and a total of twenty (20) prize symbols under a scratch-off material covering the game play data area.
- (b) Each play symbol includes a caption that corresponds with and verifies the play symbol as follows:

- (d) If a question arises as to a play or prize symbol, the caption that corresponds with the play or prize symbol will be used for final clarification.
  - 4. The:
  - (1) retailer validation code;
  - (2) game/pack/ticket number; and
  - (3) validation number;

that appear on each ticket in scratch-off game number 2334 are for Commission or retailer use only and cannot be used or played as a play or prize symbol to win a prize.

- 5. (a) To play a ticket in scratch-off game number 2334, the ticket must be validly purchased and the scratch-off material covering the game play data area must be fully removed.
- (b) If any of the play symbols in the area labeled "YOUR NUMBERS" match any of the play symbols in the area labeled "WINNING NUMBERS", the ticket may be redeemed for a prize in the amount represented by the prize symbol that is located directly below and corresponding to the matching play symbol.
- (c) If a "WIN" (MONEY BAG) play symbol is revealed in the area labeled "YOUR NUMBERS", the ticket may be redeemed for a prize represented by the

prize symbol that is located directly below and corresponding to the "MIN" (MONEY BAG) play symbol.

- (d) If a "MINDX" (5X) play symbol is revealed in the area labeled "YOUR NUMBERS", the ticket may be redeemed for a prize five (5) times the amount represented by the prize symbol that is located directly below and corresponding to
- the "WIN5X" (5X) play symbol.
- (e) If a "HINSTOO" (100) play symbol is revealed in the area labeled "YOUR NUMBERS", the ticket may be redeemed for one hundred dollars (\$100).

- (b) The number of prizes and the estimated odds provided in subsection (a) are calculated based on total print quantity of tickets. The actual number of prizes and the chances of winning a prize will vary depending on the actual quantity of tickets printed and as prizes are claimed.
- (c) If the print quantity is changed during production of this game or due to subsequent reorders of the game, the ratio of prizes and total value of all prizes to the print quantity will be proportionately maintained so that the overall odds and prize payout percentage will approximate the values provided in subsection (a).
