

Game Number 2429 MONEY MULTIPLIER

1. The name of scratch-off game number 2429 is "MONEY MULTIPLIER".

2. Tickets in scratch-off game number 2429 shall sell for twenty dollars (\$20) per ticket, unless otherwise adjusted by temporary price reductions or other promotional activities conducted or authorized by the Commission.

3. (a) Each ticket in scratch-off game number 2429 shall contain a total of sixty-eight (68) play symbols and thirty (30) prize symbols under a scratch-off material covering the game play data area.

(b) Each play symbol includes a caption that corresponds with and verifies the play symbol as follows:

(c) Each prize symbol includes a caption that corresponds with and verifies the prize symbol as follows:

(d) If a question arises as to a play or prize symbol, the caption that corresponds with the play or prize symbol will be used for final clarification.

4. The:

(1) retailer validation code;

(2) game/pack/ticket number; and

(3) validation number;

that appear on each ticket in scratch-off game number 2429 are for Commission or retailer use only and cannot be used or played as a play or prize symbol to win a prize.

5. (a) To play a ticket in scratch-off game number 2429, the ticket must be validly purchased and the scratch-off material covering the game play data area must be fully removed.

(b) If any of the play symbols in the area labeled "YOUR NUMBERS" match any of the play symbols in the area labeled "WINNING NUMBERS", the ticket may be redeemed for a prize in the amount represented by the prize symbol that is located directly below and corresponding to the matching play symbol.

(i) If a prize is won and a "ITME" (1X) play symbol is revealed underneath the winning prize symbol, the ticket may be redeemed for a prize in the amount represented by the prize symbol that is located directly above and corresponding to the winning prize symbol.

(ii) If a prize is won and a "5TIMES" (5X) play symbol is revealed underneath the winning prize symbol, the ticket may be redeemed for five (5) times the prize amount represented by the prize symbol that is located directly above and corresponding to the winning prize symbol.

(iii) If a prize is won and a "10TIMES" (10X) play symbol is revealed underneath the winning prize symbol, the ticket may be redeemed for ten (10) times the prize amount represented by the prize symbol that is located directly above and corresponding to the winning prize symbol.

(iv) If a prize is won and a "^{20TIMES}"(20X) play symbol is revealed underneath the winning prize symbol, the ticket may be redeemed for twenty (20) times the prize amount represented by the prize symbol that is located directly above and corresponding to the winning prize symbol.

(v) If a prize is won and a "50TMES" (50X) play symbol is revealed underneath the winning prize symbol, the ticket may be redeemed for fifty (50) times the prize amount represented by the prize symbol that is located directly above and corresponding to the winning prize symbol.

(vi) If a prize is won and a "100XIMES" (100X) play symbol is revealed underneath the winning prize symbol, the ticket may be redeemed for one hundred (100) times the prize amount represented by the prize symbol that is located directly above and corresponding to the winning prize symbol.

6. (a) The approximate number of possible prizes and the estimated odds for each prize level are as follows:

Prize payout:	73.02%
Overall odds:	1 in 4.63

(b) The number of prizes and the estimated odds provided in subsection (a) are calculated based on total print quantity of tickets. The actual number of prizes and the chances of winning a prize will vary as prizes are claimed.

(c) If there are reorders of the game, the ratio of prizes and total value of all prizes to the print quantity will be proportionately maintained so that the overall odds and prize payout percentage will approximate the values provided in subsection (a).

(a) In accordance with Section 6, this game has been reordered, with the process starting on September 19, 2022. The total approximate number of possible prizes and the estimated odds, updated for the reorder, for each prize level are now as follows:

(b) The number of prizes and the estimated odds provided in subsection (a) are calculated based on total print quantity of tickets. The actual number of prizes and the chances of winning a prize will vary depending on the actual quantity of tickets printed and as prizes are claimed.

(c) If the print quantity is changed during production of this game or due to subsequent reorders of the game, the ratio of prizes and total value of all prizes to the print quantity will be proportionately maintained so that the overall odds and prize payout percentage will approximate the values provided in subsection (a).
