



## CASH 5 GAME RULES

### **1. Name**

The name of this draw game is "Cash 5".

### **2. Definitions**

(a) The definitions in this section apply throughout these game rules.

(b) "Cash 5 selection event" means a drawing or other selection event conducted to determine the winning combination of characters in Cash 5.

(c) "Winning Cash 5 numbers" means the five (5) numbers determined in a Cash 5 selection event and announced as winning numbers under section 7 of these game rules.

### **3. Ticket price**

The price of a ticket for Cash 5 shall be one dollar (\$1) for each play.

### **4. Procedure for playing**

(a) A single play, applicable to a particular Cash 5 selection event, shall include the selection of five (5) numbers ranging from one (1) to forty-one (41).

(b) A ticket for Cash 5 may represent one (1) or more plays.

(c) A valid ticket for a Cash 5 selection event must originate from the Commission. A ticket may only be issued after the information and purchaser elections required by these game rules are entered into a terminal.

(d) A ticket is the only valid proof of a play and the only valid receipt for claiming a prize in Cash 5. A playslip shall have no pecuniary or prize value and shall not constitute evidence of purchase of a ticket or a play.

(e) Unless otherwise indicated on the ticket, a ticket for Cash 5 is effective for the next scheduled Cash 5 selection event.

(f) Subject to the restrictions of 65 IAC 7-1-6, the Commission may offer multi-draw tickets for Cash 5 that are effective for up to twenty-eight (28) consecutive selection events.

(g) Sales of tickets for Cash 5 shall be suspended prior to the time of each Cash 5 selection event at a time determined by the director.

(h) If a playslip is used to select a player's numbers for a Cash 5 selection event, the playslip must have been issued by the Lottery and completed by hand. The playslip will be scanned by the terminal or keyed in by hand by the retailer.

(i) A ticket for Cash 5 shall be cancelable for up to sixty (60) minutes after the transaction or up to the Cash 5 selection event cutoff time, whichever is first. The draw ticket for Cash 5 can only be cancelled by the terminal from which it was sold.

(j) The director may provide for the generation of entry tickets from terminals for certain purchases of tickets for Cash 5.

#### **5. Determination of estimated jackpot amount**

(a) The director or the director's designee shall announce the estimated cash jackpot amount prior to each Cash 5 selection event.

(b) The estimated lump sum jackpot amount for a particular Cash 5 selection event shall include:

- (1) fifty thousand dollars (\$50,000) in the first selection event following the last selection event in which a player won the jackpot prize; and
- (2) an additional increase, determined by the director, for the selection event for each consecutive selection event after the first selection event following the last selection event in which a player won the jackpot prize.

#### **6. Determination of winning numbers**

Selection events for determination of winning numbers for Cash 5 shall be held daily in accordance with 65 IAC 7-1-8 at a time to be determined by the director.

#### **7. Determination of winners**

(a) Each holder of a valid ticket for a Cash 5 selection event on which five (5) numbers in a play applicable to that selection event match the five (5) winning Cash 5 numbers is entitled to the jackpot amount or an equal share of the jackpot amount in the event multiple plays match the winning Cash 5 numbers.

(b) Each holder of a valid ticket for a Cash 5 selection event on which four (4) numbers in a play applicable to that selection event match four (4) of the five (5) winning Cash 5 numbers is entitled to a set prize of one hundred fifty dollars (\$150).

(c) Each holder of a valid ticket for a Cash 5 selection event on which three (3) numbers in a play applicable to that selection event match three (3) of the five (5) winning Cash 5 numbers is entitled to a set prize of ten dollars (\$10).

(d) Each holder of a valid ticket for a Cash 5 selection event on which two (2) numbers in a play applicable to that selection event match two (2) of the five (5) winning Cash 5 numbers is entitled to a set prize of a free Cash 5 Quick Pick ticket in the next scheduled Cash 5 selection event following redemption of the winning ticket.

#### **8. Payment of prizes**

(a) Each prize in Cash 5 shall be paid in a single lump sum payment or ticket.

(b) If a valid ticket for Cash 5 contains more than one (1) play entitled to a prize, the prize amounts for the winning plays shall be added together for purposes of claiming the prizes and determining whether the total prize amounts may be claimed from a retailer.

(c) Pari-mutuel prizes may be rounded down so that the prizes may be paid in an equal share of the jackpot amount in the event multiple plays match the winning Cash 5 numbers.

## **9. Odds of winning**

- (a) The odds of a single play winning the jackpot prize in Cash 5 are approximately 1:749,398.
- (b) The odds of a single play winning a one hundred fifty dollar (\$150) prize in Cash 5 by matching four (4) of the winning Cash 5 numbers are approximately 1:4,163.
- (c) The odds of a single play winning a ten dollar (\$10) prize in Cash 5 by matching three (3) of the winning Cash 5 numbers are approximately 1:119.
- (d) The odds of a single play winning a free Cash 5 Quick Pick ticket by matching two (2) of the winning Cash 5 numbers are approximately 1:11.
- (e) The overall odds of winning a prize in Cash 5 are approximately 1:9.6.

## **10. Add-on name**

The name of this instant win draw game add-on for Cash 5 is "EZmatch".

## **11. Add-on ticket price**

The price for an EZmatch play shall be one dollar (\$1) per each play.

## **12. Procedure for playing add-on**

- (a) A single EZmatch play shall include five (5) unique numbers each ranging from one (1) to forty-one (41) and each automatically generated.
- (b) An EZmatch play will only be valid if the purchaser elects to play EZmatch and the terminal generated ticket says "YES" to affirmatively indicate that the EZmatch play was elected. EZmatch numbers will only print on a Cash 5 ticket if the player elects to participate in the EZmatch game. If the purchaser does not elect to play EZmatch, the terminal generated ticket says "NO" to indicate that the EZmatch play was not elected.
- (c) EZmatch will only apply to the boards in which it is selected.
- (d) If a player elects to play multiple boards, the terminal will generate separate tickets for each board selected.
- (e) The selection of the multi-draw option for Cash 5 and an election of the EZmatch play will result in EZmatch being applied to the first draw only.
- (f) A ticket may win on both Cash 5 and EZmatch.
- (g) A ticket with an EZmatch win can be claimed immediately or wait until after the Cash 5 selection event. If an EZmatch winning ticket is claimed prior to the Cash 5 selection event for the date printed on the ticket of purchase, an exchange ticket, a valid instrument given in exchange for claiming an EZmatch prize won including the same Cash 5 numbers on the purchased ticket, will be issued and valid for the next selection event.
- (h) A ticket in which Cash 5 and EZmatch are purchased shall not be cancelable.

## **13. Determination of add-on winners**

If any Cash 5 number(s) on the ticket matches any number(s) of the add-on game, EZmatch, the ticket holder instantly wins the prize amount(s) shown next to the EZmatch number(s).

**14. Payment of add-on prizes**

(a) If the Cash 5 selection event for the date printed on the ticket of purchase has not occurred and a valid Cash 5 and EZmatch ticket contains one (1) play entitled to an EZmatch prize, the EZmatch prize can be claimed immediately.

(b) If the Cash 5 selection event for the date printed on the ticket of purchase has occurred and a valid Cash 5 and EZmatch ticket contains one (1) play entitled to a Cash 5 prize and one (1) play entitled to an EZmatch prize, the prize amounts for the winning plays shall be added together for purposes of claiming the prizes and determining whether the total prize amounts may be claimed from a retailer.

**15. Odds of winning the add-on**

(a) The odds of a single play winning a five hundred dollar (\$500) prize in EZmatch are approximately 1:84,000.

(b) The odds of a single play winning a two hundred fifty dollar (\$250) prize in EZmatch are approximately 1:42,000.

(c) The odds of a single play winning a one hundred dollar (\$100) prize in EZmatch are approximately 1:12,000.

(d) The odds of a single play winning a fifty dollar (\$50) prize in EZmatch are approximately 1:4,200.

(e) The odds of a single play winning a twenty dollar (\$20) prize in EZmatch are approximately 1:1,680.

(f) The odds of a single play winning a fifteen dollar (\$15) prize in EZmatch are approximately 1:840.

(g) The odds of a single play winning a ten dollar (\$10) prize in EZmatch are approximately 1:105.

(h) The odds of a single play winning a five dollar (\$5) prize in EZmatch are approximately 1:280.

(i) The odds of a single play winning a four dollar (\$4) prize in EZmatch are approximately 1:70.

(j) The odds of a single play winning a three dollar (\$3) prize in EZmatch are approximately 1:15.

(k) The odds of a single play winning a two dollar (\$2) prize in EZmatch are approximately 1:10.

(l) The overall odds of winning a prize in EZmatch are approximately 1:5.1.
