



**Game Number 2098  
10X THE MONEY**

1. The name of scratch-off game number 2098 is "10X THE MONEY".

2. Tickets in scratch-off game number 2098 shall sell for two dollars (\$2) per ticket, unless otherwise adjusted by temporary price reductions or other promotional activities conducted or authorized by the Commission.

3. (a) Each ticket in scratch-off game number 2098 shall contain a total of thirteen (13) play symbols and a total of ten (10) prize symbols under a scratch-off material covering the game play data area.

(b) Each play symbol includes a caption that corresponds with and verifies the play symbol as follows:

1 ONE	3 THR	4 FOR	6 SIX	7 SVN
8 EGT	9 NIN	11 ELV	12 TLV	13 THM
14 FRN	15 FTN	16 SXT	17 SVT	18 EGN
19 NFT	20 TWY	21 TTO	22 TTH	23 TTR

(c) Each prize symbol includes a caption that corresponds with and verifies the prize symbol as follows:

\$2.00 TWO	\$4.00 FOUR	\$5.00 FIVE	\$10.00 TEN	\$20.00 TWENTY
\$50.00 FIFTY	\$100 ONE HUN	\$500 FIV HUN	\$1,000 ONE THOU	\$10,000 TEN THOU

(d) If a question arises as to a play or prize symbol, the caption that corresponds with the play or prize symbol will be used for final clarification.

4. The:

- (1) retailer validation code;
- (2) game/pack/ticket number; and
- (3) validation number;

that appears on each ticket in scratch-off game number 2098 are for Commission or retailer use only and cannot be used or played as a play or prize symbol to win a prize.

5. (a) To play a ticket in scratch-off game number 2098, the ticket must be validly purchased and the scratch-off material covering the game play data area must be fully removed.

(b) If any of the play symbols in the area labeled “YOUR NUMBERS” match the play symbol in the area labeled “WINNING NUMBERS”, the ticket may be redeemed for a prize in the amount represented by the prize symbol that is located directly below and corresponding with the matching play symbol.



(c) If a “WIN2X” play symbol is revealed in the area labeled “YOUR NUMBERS”, then the ticket may be redeemed for a prize two (2) times the amount represented by the prize symbol that is located directly below and corresponds with



the “WIN2X” play symbol.



(d) If a “WIN5X” play symbol is revealed in the area labeled “YOUR NUMBERS”, then the ticket may be redeemed for a prize five (5) times the amount represented by the prize symbol that is located directly below and corresponds with



the “WIN5X” play symbol.



(d) If a “WIN10X” play symbol is revealed in the area labeled “YOUR NUMBERS”, then the ticket may be redeemed for a prize ten (10) times the amount represented by the prize symbol that is located directly below and corresponds with



the “WIN10X” play symbol.

6. (a) The approximate number of possible prizes and the estimated odds for each prize level are as follows:

(b) The number of prizes and the estimated odds provided in subsection (a) are calculated based on total print quantity of tickets. The actual number of prizes and the chances of winning a prize will vary depending on the actual quantity of tickets printed and as prizes are claimed.

(c) If the print quantity is changed during production of this game or due to subsequent reorders of the game, the ratio of prizes and total value of all prizes to the print quantity will be proportionately maintained so that the overall odds and prize payout percentage will approximate the values provided in subsection (a).
