



**RULES AND PROCEDURES GOVERNING THE HOOSIER LOTTERY'S
MYLOTTERY 2016 PACERS FAN PRIZE PACK GIVEAWAY**

The State Lottery Commission of Indiana (“Hoosier Lottery” or “Lottery”), hereby promulgates these rules and procedures (“Official Rules”) governing the Hoosier Lottery’s **mylottery** 2016 Pacers Fan Prize Pack Giveaway (“Promotion”). This Promotion is open to participants who become eligible for participation by complying with these rules and procedures. **NO PURCHASE NECESSARY.** This Promotion is void where prohibited.

A. PURPOSE

The Promotion will be held to support the Hoosier Lottery’s loyalty program (**mylottery**) by providing members of the Hoosier Lottery loyalty program the opportunity to enter the Promotion for a chance to win a prize. As part of this Promotion, there will be ten (10) prizes total awarded: one (1) Grand Prize, five (5) First Prizes and four (4) Second Prizes. Descriptions of each prize are found below in Section C.

B. PROMOTION PERIOD & DRAWING DESCRIPTION

1. The Promotion period will begin on or about 12:00am (ET) on Saturday, November 19, 2016 and the final entry deadline shall be at 11:59pm (ET) on Monday, December 12, 2016.
2. The official winner selections will be drawn on or about Tuesday, December 13, 2016 at the Hoosier Lottery offices located at 1302 N. Meridian Street, Indianapolis, IN 46202.

C. PROMOTION & PRIZE DESCRIPTIONS

1. The drawings and Promotion will be conducted in accordance with all applicable statutes, regulations, rules and procedures and the drawings will occur on or about the following day for the listed prizes:

On or about Tuesday, December 13, 2016	One (1)	Grand Prize: Two (2) Lower Level tickets to the Indiana Pacers game played against the Chicago Bulls on December 30, 2016 (\$125/ticket value; \$250 total value), one (1) autographed Indiana Pacers jersey (\$110 value), two (2) Indiana Pacers hats (\$13/hat value; \$26 total

		value), and one (1) merchandise prize pack (\$100 value). Total Grand Prize value of \$486.
On or about Tuesday, December 13, 2016	Five (5)	First Prize: Two (2) Balcony Level tickets to the Indiana Pacers game played against the Chicago Bulls on December 30, 2016 (\$15/ticket value; \$30 total value), one (1) autographed Indiana Pacers jersey (\$110 value), two (2) Indiana Pacers hats (\$13/hat value; \$26 total value), and one (1) merchandise prize pack (\$100 value). Total First Prize value of \$266.
On or about Tuesday, December 13, 2016	Four (4)	Second Prize: One (1) autographed Indiana Pacers jersey (\$110 value), two (2) Indiana Pacers hats (\$13/hat value; \$26 total value), and one (1) merchandise prize pack (\$100 value). Total Second Prize value of \$236.

2. Retail values reflect unautographed merchandise. Retail value of hand signed merchandise is subject to fluctuation based on the featured player(s) and current market value at the time of prize award. Total retail value of all prizes combined is \$2,760.
3. Winners and each of their guests must agree to comply with all NBA venue rules and regulations relating to the use of NBA regular season tickets and, in accordance therewith, agree not to act in an unsportsmanlike or disruptive manner, or with any intent to annoy, abuse, threaten or harass any other person at such game. Failure to do so may result in forfeiture of prize or prize element.

D. ELIGIBILITY

1. This Promotion is open to legal residents of Indiana who are eighteen (18) years of age or older at the time of entry.

2. State Lottery Commission of Indiana members, officers, and employees, and any relative(s) (spouse, parents, siblings and children) and/or person(s) residing in the same household of such Hoosier Lottery member, officer, or employee are not eligible to participate in or win this Promotion. This restriction applies *mutatis mutandis* to the Lottery's Integrated Service Provider, IGT Indiana, LLC ("IGT").
3. Members, directors, officers, or employees of a major procurement vendor of the Hoosier Lottery and/or IGT, and any relative(s) (spouse, parents, siblings and children) and/or person(s) residing in the same household of such persons are not eligible to participate in or win this Promotion.
4. Employees and immediate families of employees (spouse, parents, siblings and children) of Pacers Basketball, LLC d/b/a Indiana Pacers, Pacers Sports & Entertainment and Home Court ("Pacers"), the National Basketball Association and its Teams, NBA Properties, Inc. and each of their respective parents, subsidiaries, affiliates, directors, officers, owners, members, employees and agents are not eligible to participate in or win this Promotion.

E. HOW TO PARTICIPATE

1. Participants must have a current **mylottery** account in good standing and click on the "Enter Now" button in the promotion areas located on the **mylottery** member's dashboard.
2. If a participant does not have a **mylottery** account they can sign up for a free account at www.hoosierlottery.com/mylottery/sign-up. Once the participant confirms their account, they can log into their **mylottery** account and enter the Promotion.
3. A participant may only enter the Promotion once. Duplicate entries will be removed at the time of the drawing.
4. An automated "Thank You" message will be sent via email to notify the participant of a completed entry into the Promotion. The "Thank You" email notification is only evidence that an entry has been received and does not indicate that the entry is valid.
5. All entries submitted in the manner as described in these Official Rules will be eligible for an entry in this Promotion. Hand delivered or mailed in entries will not be accepted for this Promotion and will be deemed invalid and destroyed.

F. ODDS OF WINNING

The odds of winning a prize are dependent upon the total number of entries received.

G. DRAWING, WINNER NOTIFICATION AND CLAIMING OF PRIZE

1. Winning entries will be selected from among all eligible entries received by using a random number generator under the supervision of a member of the Hoosier Lottery Security team.
2. One (1) alternate per prize, for a total of ten (10) alternates, will be selected by using a random number generator from random.org under the supervision of a member of the Hoosier Lottery Security team.
3. The selected winners for this Promotion will be notified via email and telephone number provided from the participant's **mylottery** member account.
4. Upon timely presentation of winner information, the entry will be validated and eligibility will be verified as in Section D ("Eligibility").
5. Upon notification, winners will have forty-eight (48) hours to respond and to claim prize. If winner does not respond within forty-eight (48) hours, an alternate winner may be contacted. If alternate(s) fail to claim the prize, the prize will be forfeited.
6. Prizes will be mailed, if within the state of Indiana, or available to be picked up at Hoosier Lottery Headquarters located at 1302 North Meridian Street, Indianapolis, IN 46202.
7. Winners are required to provide a valid government-issued ID or verify mylottery information to claim their prize.
8. Prizes must be claimed by person who entered, but prizes are transferable.

H. GENERAL RULES AND PROVISIONS

1. The rules and procedures set forth in these Official Rules shall govern this Promotion. These rules may be amended at any time by the Hoosier Lottery without advance notice.
2. The Hoosier Lottery's Executive Director or her designee may, at any time, announce a suspension or termination of the Promotion, without advance notice and in the Executive Director's sole discretion, at which point no prize shall be awarded. The Hoosier Lottery, the Executive Director, IGT, Pacers, the National Basketball Association and its Member Teams, NBA Properties, Inc. nor any employee thereof, shall have any liability whatsoever for any such termination.
3. By participating in the Promotion each person agrees to comply with and abide by Indiana law, rules, and regulations as well as the terms and conditions of the Hoosier Lottery website and all final decisions, policies, or procedures of the Hoosier Lottery in relation to the conduct of this Promotion. Any dispute arising which relates to any aspect of this Promotion shall be governed by the laws of Indiana.
4. In the event of a dispute arising out of these Official Rules, the participant's remedy is limited to entry in another promotion with prizes of a similar value.

5. The Hoosier Lottery, IGT, Pacers, the National Basketball Association and its Member Teams, NBA Properties, Inc. and their agents are not responsible for error, omission, interruption, deletion, defect, delay in operations, theft or destruction, unauthorized access to or alterations of Promotion, failure to receive claim, winner, or other Promotion information for any reason whatsoever.
6. The Hoosier Lottery, Pacers, the National Basketball Association and its Member Teams, and NBA Properties, Inc. are not responsible for issues with account accessibility or Promotion entries due to technical problems associated to software, hardware compatibility or internet access.
7. Except where prohibited by law, in consideration for being permitted to participate in this Promotion and the opportunity to win the prizes offered in this Promotion, each participant hereby agrees and consents, without further authorization, compensation or remuneration of any kind, to the use of the entrant's name, likeness, voice, photograph, performance, personal statements and/or biographical information in any and all advertising, promotions and other publicity conducted by Hoosier Lottery, IGT, Pacers and/or the National Basketball Association and its Member Teams, NBA Properties, Inc. and each of their respective parents, subsidiaries, affiliates, agents, licensees, successors and assigns.
8. By entering this Promotion, each Promotion participant agrees to follow the Official Rules and forever releases, discharges, and waives any and all claims, liabilities and actions of any kind, howsoever caused or arising and whether by negligence, any intentional act or otherwise, that entrant may have or that may arise against the Hoosier Lottery, IGT, Facebook, Instagram, Pacers, the National Basketball Association and its Teams, NBA Properties, Inc. and each of their respective parents, subsidiaries, affiliates, and related entities, as well as each of the aforementioned parties' respective associates, directors, officers, owners, shareholders, partners, members, employees, agents, representatives, successors and assigns (collectively, the "Released Parties"), with respect to or arising directly or indirectly, out of, or in any way connected with, (i) participant's participation in this Promotion; or (ii) the receipt or use of the prize (including but not limited to the substitution or changing of any prizing) awarded in connection with this Promotion. This promotion is in no way sponsored, endorsed, or administered by, or associated with, Facebook or Instagram. Participants understand that they are providing their information to Hoosier Lottery and/or IGT and not to Facebook or Instagram.
