



**RULES AND PROCEDURES GOVERNING THE HOOSIER LOTTERY'S
MYLOTTERY 2016 INDY FUEL GIVEAWAY**

The State Lottery Commission of Indiana (“Hoosier Lottery” or “Lottery”), hereby promulgates these rules and procedures (“Official Rules”) governing the Hoosier Lottery’s **mylottery** 2016 Indy Fuel Giveaway or (“Promotion”). This Promotion is open to players who become eligible for participation by complying with these Official Rules. NO PURCHASE NECESSARY.

A. PURPOSE

The Promotion will be held to support the Hoosier Lottery’s loyalty program (**mylottery**) by providing members the opportunity to enter the 2016 Indy Fuel Giveaway which will award three (3) prizes. Descriptions of the prize are found below in Section C.

B. PROMOTION PERIOD & DRAWING DESCRIPTION

1. The Promotion period will begin on or about 12:00am (ET) on Saturday, November 19, 2016 and the final entry deadline shall be at 11:59pm (ET) on Monday, December 12, 2016.
2. The official selections will be drawn on or about Tuesday, December 13, 2016 at the Hoosier Lottery offices located at 1302 N. Meridian Street, Indianapolis, IN 46202.

C. PROMOTION & PRIZE DESCRIPTIONS

1. The drawings will be conducted in accordance with all applicable statutes, regulations, rules and procedures and will occur on or about the following day for the listed Prize:

Date of Drawing	Number of Prizes	Description of Prize
On or about Tuesday, December 13, 2016	One (1)	Four (4) tickets to three (3) Indy Fuel Home Games: January 1, 2017, January 14, 2017, and January 20, 2017. Total Value is \$480.

On or about Tuesday, December 13, 2016	One (1)	Four (4) tickets to three (3) Indy Fuel Home Games: January 21, 2017, January 22, 2017, and January 27, 2017. Total Value is \$480.
On or about Tuesday, December 13, 2016	One (1)	Four (4) tickets to two (2) Indy Fuel Home Games: January 28, 2017, January 29, 2017, and February, 4, 2017. Total Value is \$480.

D. ELIGIBILITY

1. This Promotion is open to individuals eighteen (18) years of age or older.
2. State Lottery Commission of Indiana members, officers, and employees, and any relative(s) residing in the same household of such Hoosier Lottery member, officer, or employee are not eligible to participate in this Promotion. This restriction applies *mutatis mutandis* to the Lottery's Integrated Service Provider, IGT Indiana, LLC ("IGT").
3. Members, directors, officers, or employees of a major procurement vendor of the Hoosier Lottery and/or IGT, and any relative(s) residing in the same household of such persons are not eligible to participate in this Promotion.

E. HOW TO PARTICIPATE

1. Participants must have a current **mylottery** account in good standing and click on the "Enter Now" button in the promotion areas located on the **mylottery** member's dashboard.
2. If a player does not have a **mylottery** account they can sign up for a free account at www.hoosierlottery.com/mylottery/sign-up. Once the player confirms their account, they can log into their **mylottery** account and enter the Promotion.
3. A player may only enter the Promotion once. Duplicate entries will be removed at the time of the drawing.
4. An automated "Thank You" message and email will notify the player of a completed entry into the Promotion. The "Thank You" email notification is only evidence that an entry has been received and does not indicate that the entry is valid.

5. All entries submitted in the manner as described in these Official Rules will be eligible for an entry in this Promotion. Hand delivered or mailed in entries will not be accepted for this Promotion and will be deemed invalid and destroyed.

F. ODDS OF WINNING

The odds of winning the Prize are dependent upon the total number of entries received.

G. DRAWING, WINNER NOTIFICATION AND CLAIMING OF PRIZE

1. The winning entries will be selected by using a random number generator under the supervision of a member of the Hoosier Lottery Security team.
2. Four (4) alternates will be selected by using a random number generator from random.org under the supervision of a member of the Hoosier Lottery Security team.
3. The selected winners for this Promotion will be notified via email and telephone number provided from the player's **mylottery** member account.
4. Upon timely presentation of winner information, the entry will be validated and eligibility will be verified as in Section D ("Eligibility").
5. Upon notification, the winners will have seventy-two (72) hours to respond and to claim prize. If winner does not respond within seventy-two (72) hours, an alternate will be contacted. If alternates fail to claim the prize, the prize will be forfeited.
6. Prizes will be mailed, if within the state of Indiana, or available to be picked up at Hoosier Lottery Headquarters located at 1302 North Meridian Street, Indianapolis, IN 46202.
7. The winners will be required to provide a valid government-issued ID or verify mylottery information to claim their prize.
8. Prize must be claimed by person who entered, but prizes are transferable.

H. GENERAL RULES AND PROVISIONS

1. The rules and procedures set forth in these Official Rules shall govern this Promotion. These rules may be amended at any time by the Hoosier Lottery without advance notice.
2. The Lottery's Executive Director or her designee may, at any time, announce a suspension or termination of the Promotion, without advance notice and in the Executive Director's sole discretion, at which point no Prize shall be awarded. The Lottery, the Executive Director, IGT, nor any employee thereof, shall have any liability whatsoever for any such termination.

3. By participating in the Promotion each person agrees to comply with and abide by Indiana law, rules, and regulations as well as the terms and conditions of the Lottery website and all final decisions, policies, or procedures of the Lottery in relation to the conduct of this Promotion. Any dispute arising which relates to any aspect of this Promotion shall be governed by the laws of Indiana.
4. In the event of a dispute arising out of these Official Rules, the player's remedy is limited to entry in another promotion with prizes of a similar value.
5. The Lottery, IGT, and their agents are not responsible for error, omission, interruption, deletion, defect, delay in operations, theft or destruction, unauthorized access to or alterations of Promotion, failure to receive claim, winner, or other Promotion information for any reason whatsoever.
6. The Hoosier Lottery is not responsible for issues with account accessibility or Promotion entries due to technical problems associated to software, hardware compatibility or internet access.
7. By entering this Promotion, all Promotion participants agree to indemnify, hold harmless, and waive any claims against the Hoosier Lottery, IGT, and any of the affiliates, associates, directors, officers, agents, representatives and assigns thereof arising directly or indirectly, out of, or in any way connected with, this Promotion or the Prize awarded in connection therewith.
