



**RULES AND PROCEDURES GOVERNING THE 2016
HOLIDAY GIVEAWAY**

The State Lottery Commission of Indiana (“Hoosier Lottery” or “Lottery”), hereby promulgates these rules and procedures (“Official Rules”) governing the 2016 Holiday Giveaway Promotion (“Drawing”). This Drawing is open to individuals who become eligible for participation by complying with these Official Rules.

A. PURPOSE

A Drawing will be conducted to give away fifteen (15) prizes of a Hoosier Lottery Holiday Gift Basket at dates and locations in accordance with Section C below. Hoosier Lottery Holiday Gift Baskets include Hoosier Lottery scratch-offs and/or coupons and merchandise.

B. PROMOTIONAL PERIOD & DRAWING DATE

1. The Promotional Period will begin at 11:00 a.m. EST on Friday, December 2, 2016 and will end on or about 2:00pm EST on Friday, December 16, 2016.
2. All official drawings will be conducted in accordance with Section C below.

C. DRAWINGS AND PRIZE DESCRIPTIONS

1. Drawings will be conducted by the Hoosier Lottery in accordance with all applicable statutes, rules and drawing procedures and will occur on or about the following dates and times listed below:

D. ELIGIBILITY

1. This Drawing is open to individuals eighteen (18) years of age or older.
2. State Lottery Commission of Indiana members, officers, and employees, and any relative(s) residing in the same household of such Hoosier Lottery member,

officer, or employee are not eligible to participate in this Drawing. This restriction applies *mutatis mutandis* to the Lottery's Integrated Services Provider, IGT Indiana, LLC, ("IGT").

3. Members, directors, officers, or employees of a major procurement vendor of the Hoosier Lottery and/or IGT, and any relative(s) residing in the same household of such persons are not eligible to participate in this Drawing.
4. Owners, officers, directors, or employees of licensed Hoosier Lottery retailers may not enter at any retail location where they are employed or have management responsibilities.

E. HOW TO PARTICIPATE

1. To be eligible to win a Hoosier Lottery Holiday Gift Basket, an individual must visit one of the Hoosier Lottery retail locations during the Promotional Period listed above in section C.
2. Participants must purchase five dollars (\$5) in Hoosier Lottery Holiday Scratch-off tickets to receive an official Hoosier Lottery entry form. Holiday Scratch-off tickets include the \$1 Merry/Joy/Cheer, \$2 Happy Holidays, and \$5 Merry & Bright.
3. Participants must fill out information on the official Hoosier Lottery entry form which includes participant's name, address, and phone number, and drop the entry form in the designated drawing device.
4. Participants must fill out their own information and may not enter on someone else's behalf.
5. Participants may enter more than once, but only one (1) official Hoosier Lottery entry form will be provided for every five dollar (\$5) Hoosier Lottery Holiday scratch-off purchase.
6. All entries deposited in the designated entry boxes shall become the property of the Hoosier Lottery. Other forms of entry other than an official Hoosier Lottery entry form are ineligible for the drawing and will be disqualified and destroyed.
7. Winners can only win one (1) Hoosier Lottery Holiday Gift Basket and will be disqualified if drawn at other locations in Section C.
8. Entries submitted will only be valid for the drawing(s) held on the day entered.

F. ODDS OF WINNING

The odds of winning a prize are dependent upon the total number of entries.

G. WINNER NOTIFICATION AND CLAIMING OF PRIZE

1. Winning entries for this Promotion will be drawn as stated in Section C of these Official Rules.
2. The winning entrants will be posted at the location in which the winning entry was drawn. If winners are not present, and do not claim on site, they will be contacted within two (2) business days following the drawing.
3. Winning entrants will have five (5) business days after notification to claim their prize, or else the prize will be forfeited.
4. Prizes may be claimed by mail if in the state of Indiana. If claimed by mail, prize will only be shipped to the address indicated on the official Hoosier Lottery entry form.
5. Prizes awarded during this Drawing are not transferable or assignable.
6. Each winner may be required to participate in publicity and marketing efforts. Examples include, but are not limited to, an interview with Hoosier Lottery individuals, television, radio and/or newspaper reporters and/or photographers/videographers. This information may be used in future media, the Hoosier Lottery's website, in store POP or other marketing efforts without additional consent or compensation to the winner.

H. COLLECTION OF ENTRIES AND STORAGE

1. A Hoosier Lottery and/or IGT employee shall designate a specific location and verify the designated drawing device is empty at the beginning of each date of the Drawing.
2. The location and container used for the drawing will be overseen by Hoosier Lottery and/or IGT employees at all times.
3. One (1) winning entry will be drawn from among all entries collected for each drawing.
4. Entries are only eligible for the date entered. All entries will be discarded at the end of each of the drawings.

I. DRAWING PROCEDURES

1. The Senior Manager of PR and Promotions or Promotions Manager shall designate an employee of the Hoosier Lottery or IGT to act as the Drawing Manager responsible for coordinating and conducting the Drawing. The Drawing will be conducted by IGT or Hoosier Lottery personnel in accordance with Hoosier Lottery rules and regulations.
2. The Drawing Manager will inspect the designated drawing device to ensure it is empty prior to putting it out for each drawing.

3. At each specified draw time the Drawing Manager will ensure all entries have been thoroughly mixed within the designated drawing device. Only one (1) entry will be drawn at a time. The Drawing Manager shall designate an employee of the Hoosier Lottery, IGT or other ineligible party to act as the Drawing Designee to select one (1) entry from the drawing device. The entry will be given to the designated Drawing Manager, who will verify the entry.
4. The name on the entry will be recorded at which time that individual's name will be announced to the crowd if qualified. If a selected entry is disqualified, the Drawing Manager shall direct the Drawing Designee to select another entry from the drawing device. All decisions made by the Drawing Manager related to this promotion shall be final.
5. If no valid claim is made, the prizes will be forfeited.
6. To claim a prize, a prospective winner, whose entry was selected to win the prize, must meet all eligibility requirements based on rules for this Drawing and all other lottery laws and regulations.
7. An entry will be disqualified for the following reasons:
 1. The entry was not entered by the date and time designated in these Official Rules.
 2. The entry is not the designated official Hoosier Lottery entry form.
 3. An entry was received from a person not eligible to enter.
 4. The winner does not claim prize within time allowed.
 5. Entry was illegible.
 6. Any other reason for disqualification contained in Lottery rules, regulations, or state law.
8. The Drawing Manager shall maintain all drawn entries and disqualified entries.

J. GENERAL RULES AND PROVISIONS

1. The rules and procedures set forth in these Official Rules shall govern this Drawing. These rules may be amended at any time by the Hoosier Lottery without advance notice.
2. The Hoosier Lottery's Executive Director or her designee may, at any time, may announce a suspension or termination of the Drawing, without advance notice and in the Executive Director's sole discretion, at which point no Prize shall be awarded. The Hoosier Lottery, the Executive Director, IGT Indiana, nor any employee thereof, shall have any liability whatsoever for any such termination.
3. By participating in the Drawing each person agrees to comply with and abide by Indiana law, rules, and regulations as well as the terms and conditions of the Lottery website and all final decisions, policies, or procedures of the Hoosier Lottery in relation to the conduct of this Drawing. Any dispute arising which relates to any aspect of this Drawing shall be governed by the laws of Indiana.
4. The Hoosier Lottery, IGT, and their agents are not responsible for error, omission, interruption, deletion, defect, delay in operations, theft or destruction,

unauthorized access to or alterations of Drawing, failure to receive claim, winner, or other Drawing information for any reason whatsoever.

5. The liability of the Hoosier Lottery for failure to enter any person into this Drawing, for any improper operation or conduct of this Drawing, or for the failure of any person to win a prize in this Drawing is limited to entry of the aggrieved person in another promotional drawing with prizes of similar value. Each participant in this Drawing agrees by the act of participating in this Drawing to this limitation of liability.
6. By participating in the Drawing, all participants agree to indemnify, hold harmless, and waive any claims against the Hoosier Lottery, IGT Indiana, or any of their affiliates, associates, directors, officers, agents, representatives and assigns arising directly or indirectly, out of, or in any way connected with, this Drawing or the prize awarded in connection therewith.
