



**RULES AND PROCEDURES GOVERNING THE HOOSIER LOTTERY'S
MYLOTTERY INDIANAPOLIS COLTS vs. ARIZONA CARDINALS
GIVEAWAY**

The State Lottery Commission of Indiana ("Hoosier Lottery" or "Lottery"), hereby promulgates these rules and procedures ("Official Rules") governing the Hoosier Lottery's **myLOTTERY** Indianapolis Colts vs. Arizona Cardinals Giveaway ("Promotion"). This Promotion is open to players who become eligible for participation by complying with these rules and procedures.

A. PURPOSE

The Promotion will be held to support the Hoosier Lottery's loyalty program (**myLOTTERY**) by providing members the opportunity to enter the Indianapolis Colts vs. Arizona Cardinals Giveaway which will award one (1) winner a set of two (2) tickets to the Indianapolis Colts vs. Arizona Cardinals on Sunday, September 17, 2017 at Lucas Oil Stadium.

B. PROMOTION PERIOD & DRAWING DESCRIPTION

1. The Promotion period will begin at 12:00pm (ET) on Monday, September 4, 2017 and the final entry deadline shall be at 11:59pm (ET) on Wednesday, September 6, 2017.
2. The official selections will be drawn on or about Thursday, September 7, 2017 at the Hoosier Lottery offices located at 1302 N. Meridian Street, Indianapolis, IN 46202.

C. PROMOTION & PRIZE DESCRIPTIONS

1. The drawings will be conducted in accordance with all applicable statutes, regulations, rules and procedures and will occur on or about Thursday, September 7, 2017 for the listed Prizes:

Drawing Date (on or about)	Number of Prizes	Description of Prize
Thursday, September 7, 2017	One (1)	Two (2) Tickets to Indianapolis Colts vs. Arizona Cardinals on September 17, 2017 at Lucas Oil Stadium. Total Value of \$496. (\$248 per ticket)

D. ELIGIBILITY

1. This Promotion is open to individuals eighteen (18) years of age or older.
2. State Lottery Commission of Indiana members, officers, and employees, and any relative(s) residing in the same household of such Hoosier Lottery member, officer, or employee are not eligible to participate in this Promotion. This restriction applies *mutatis mutandis* to the Lottery's Integrated Service Provider, IGT Indiana, LLC ("IGT").
3. Members, directors, officers, or employees of a major procurement vendor of the Hoosier Lottery and/or IGT, and any relative(s) residing in the same household of such persons are not eligible to participate in this Promotion.

E. HOW TO PARTICIPATE

1. Participants must have a current **myLOTTERY** account in good standing and click on the "Enter Now" button in the promotion areas located on the **myLOTTERY** member's dashboard.
2. If a player does not have a **myLOTTERY** account they can sign up for a free account at www.hoosierlottery.com/mylottery/sign-up. Once the player confirms their account, they can log into their **myLOTTERY** account and enter the Promotion.
3. A player may only enter the Promotion once. Duplicate entries will be removed at the time of the drawing.
4. An automated "Thank You" message will notify the player of a completed entry into the Promotion. The "Thank You" message is only evidence that an entry has been received and does not indicate that the entry is valid.
5. All entries submitted in the manner as described in these Official Rules will be eligible for an entry in this Promotion. Hand delivered or mailed in entries will not be accepted for this Promotion and will be deemed invalid and destroyed.
6. Winning entries in addition to three (3) alternates will be selected by using a random number generator from random.org under the supervision of a member of the Hoosier Lottery Security team.

F. ODDS OF WINNING

The odds of winning a Prize are dependent upon the total number of entries received.

G. WINNER NOTIFICATION AND CLAIMING OF PRIZE

1. The winning entries for this Promotion will be notified via email and telephone number provided from the player's **myLOTTERY** member account.
2. Upon timely presentation of winner information, the entry will be validated and eligibility will be verified as in Section D ("Eligibility").
3. Upon contact, winners will have forty-eight (48) hours to respond and to claim prize. If winner does not respond within forty-eight (48) hours, an alternate will be contacted. If alternates fail to claim the prize, the prize will be forfeited.
4. Prizes will be mailed or available to be picked up at Hoosier Lottery Headquarters located at 1302 North Meridian Street, Indianapolis, IN 46202 by September 15, 2017.


5. Winners are required to show a valid government-issued ID to claim their prize.

H. GENERAL RULES AND PROVISIONS

1. The rules and procedures set forth in these Official Rules shall govern this Promotion. These rules may be amended at any time by the Hoosier Lottery without advance notice.
2. The Lottery's Executive Director or her designee may, at any time, announce a suspension or termination of the Promotion, without advance notice and in the Executive Director's sole discretion, at which point no Prize shall be awarded. The Lottery, the Executive Director, IGT, nor any employee thereof, shall have any liability whatsoever for any such termination.
3. By participating in the Promotion each person agrees to comply with and abide by Indiana law, rules, and regulations as well as the terms and conditions of the Lottery website and all final decisions, policies, or procedures of the Lottery in relation to the conduct of this Promotion. Any dispute arising which relates to any aspect of this Promotion shall be governed by the laws of Indiana.
4. In the event of a dispute arising out of these Official Rules, the player's remedy is limited to entry in another promotion with prizes of a similar value.
5. The Lottery, IGT, and their agents are not responsible for error, omission, interruption, deletion, defect, delay in operations, theft or destruction, unauthorized access to or alterations of Promotion, failure to receive claim, winner, or other Promotion information for any reason whatsoever.
6. The Hoosier Lottery is not responsible for issues with account accessibility or Promotion entries due to technical problems associated to software, hardware compatibility or internet access.
7. By entering this Promotion, all Promotion participants agree to indemnify, hold harmless, and waive any claims against the Hoosier Lottery, IGT, and any of the affiliates, associates, directors, officers, agents, representatives and assigns thereof arising directly or indirectly, out of, or in any way connected with, this Promotion or the Prize awarded in connection therewith.
