



**RULES AND PROCEDURES GOVERNING THE HOOSIER LOTTERY COLTS
WEEKEND EXPERIENCE GIVEAWAY PROMOTION**

The State Lottery Commission of Indiana (“Lottery” or “Hoosier Lottery”), hereby promulgates these rules and procedures (“Official Rules”) governing the Hoosier Lottery Colts Weekend Experience Giveaway Promotion (“Promotion”).

A. PURPOSE

The Promotion will be held to award two (2) Colts Weekend Experiences valued at one thousand two hundred ninety-seven dollars (\$1,297) each.

B. PROMOTION PERIOD

The Promotion period will begin on or about 12:00 AM (ET) on Tuesday, September 19, 2017 and the Promotion entry deadline will be at 11:59 PM (ET) on Thursday, September 21, 2017.

C. PROMOTION & PRIZE DESCRIPTIONS

1. The Promotion will be conducted in accordance with all applicable statutes, regulations, rules for the listed Prizes:

Overall prize value \$1,297. |

D. ELIGIBILITY

1. This Promotion is open to legal residents of Indiana who are eighteen (18) years of age or older at the time of entry.
2. Only one (1) prize per household will be allowed.
3. State Lottery Commission of Indiana members, officers, and employees, and any relative(s) (spouse, parents, siblings and children) and/or person(s) residing in the same household of such Hoosier Lottery member, officer, or employee are not eligible to participate in this Promotion. This restriction applies *mutatis mutandis* to the Lottery's Integrated Service Provider, IGT Indiana, LLC ("IGT").
4. Members, directors, officers, or employees of a major procurement vendor of the Hoosier Lottery and/or IGT, and any relative(s) (spouse, parents, siblings and children) and/or person(s) residing in the same household of such persons are not eligible to participate in this Promotion.

E. HOW TO PARTICIPATE

1. To enter, eligible users must fill out the required entry information via the Hoosier Lottery's "Colts Weekend Experience" website form located at <https://www.hoosierlottery.com/promotions--events/colts-weekend-giveaway>. Required entry information will include first and last name, date of birth, valid phone number and valid email address.
2. Only one (1) entry per person is allowed. Duplicate entries will be removed prior to the selection of winners.
3. The winning entries will be selected from among all eligible entries received by using a random number generator under the supervision of a member of the Hoosier Lottery Security team. Five (5) alternates will be drawn.

F. ODDS OF WINNING

The odds of winning a prize are dependent upon the total number of entrants.

G. WINNER NOTIFICATION AND CLAIMING OF PRIZE

1. The winning entries for this Promotion will be notified in writing via email and by phone call with email address and phone number provided with the entrant's contact information. Winner must claim prize within 48 hours. After 48 hours, the prize may be offered to an alternate. If all alternates are exhausted, the prize(s) shall be forfeited.

2. Upon timely presentation of winner information, the entry will be validated and eligibility will be verified as in Section D (“Eligibility”).
3. The Lottery is required to determine if a prize winner has an outstanding debt to the state, owes delinquent taxes, or is past due on child support pursuant to IC 4-30-11-11. If debt is discovered, the debt will be paid with prize winnings and the balance, if any, will be paid to the winner.
4. All other costs, taxes (including all state and federal taxes), which are not paid by the Hoosier Lottery, are the sole responsibility of the winner. The Lottery will provide the winner a W2-G for tax reporting purposes.
5. Once Winner Verification and Winner Authorization are complete, Prize will be provided to Winner.
6. Prize awarded during this Promotion is transferable, but only to someone eighteen (18) years of age or older.

H. GENERAL RULES AND PROVISIONS

1. The rules and procedures set forth in these Official Rules shall govern this Promotion. These rules may be amended at any time by the Hoosier Lottery without advance notice.
2. The Lottery’s Executive Director or her designee may, at any time, announce a suspension or termination of the Promotion, without advance notice and in the Executive Director’s sole discretion, at which point no Prize shall be awarded. None of the Lottery, the Executive Director, IGT, Indianapolis Colts, or any employee thereof, shall be liable for such termination.
3. By participating in the Promotion each person agrees to comply with and abide by Indiana law, rules, and regulations as well as the terms and conditions of the Lottery website and all final decisions, policies, or procedures of the Lottery in relation to the conduct of this Promotion. Any dispute arising which relates to any aspect of this Promotion shall be governed by the laws of Indiana.
4. In the event of a dispute arising out of these Official Rules, the player’s remedy is limited to entry in another promotion with prizes of a similar value.
5. The Lottery, IGT, and their agents are not responsible for error, omission, interruption, deletion, defect, delay in operations, theft or destruction, unauthorized access to or alterations of Promotion, failure to receive claim, winner, or other Promotion information for any reason whatsoever.
6. By entering this Promotion, each entrant agrees to follow the Official Rules and forever releases, discharges, and waives any and all claims, liabilities and actions of any kind, howsoever caused or arising and whether by negligence, any intentional act or otherwise, that entrant may have or that may arise

against the Hoosier Lottery, IGT, and each of their respective parents, subsidiaries, affiliates, and related entities, as well as each of the aforementioned parties' respective associates, directors, officers, owners, shareholders, partners, members, employees, agents, representatives, successors and assigns (collectively, the "Released Parties"), with respect to or arising directly or indirectly, out of, or in any way connected with, (i) entrant's participation in this Promotion; or (ii) the receipt or use of the prizes (including but not limited to the substitution or changing of any prizes) awarded in this Promotion. By entering, each entrant further agrees to defend, indemnify and hold harmless the Released parties and their insurers against any and all damages, costs, judgments, and/or expenses (including but not limited to attorneys' fees and/or other legal fees) they may incur as a result of claims made against them in connection with either (i) entrant's participation in this Promotion; or (ii) the receipt or use of the prizes (including but not limited to the substitution or changing of any prizes) awarded in this Promotion.

7. This Promotion is void where prohibited.
